NOW, THEREFORE BE IT RESOLVED, by the governing body of Frelinghuysen Township that the rate of interest on unpaid taxes shall be eight percent (8%) per annum on the first One Thousand Five Hundred (\$1,500.00) Dollars of delinquency and 18 percent per annum on any amount in excess of One Thousand Five Hundred (\$1,500.00) Dollars to be calculated from the date the tax was payable until the date of actual payment, provided that no interest shall be charged if payment of any installment is made on or before the tenth calendar day following the date upon which the same became payable; and BE IT FURTHER RESOLVED, that in addition to the interest provided above, on all delinguencies in excess of Ten Thousand (\$10,000.00) Dollars and which are not paid prior to the end of the calendar year, the tax collector shall also collect a penalty of six (6) percent of the amount of the delinquency in excess of Ten Thousand (\$10,000.00) Dollars. BE IT FURTHER RESOLVED, that the Municipal Clerk provide a certified copy of this resolution to the Tax Collector. Motion was made by Mr. Stracco, seconded by Mr. Desiderio. All were in favor.

2016-10 AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES-MUNICIPAL AUDITOR WHEREAS, the Township of Frelinghuysen has a need to acquire a municipal Auditor as a non-fair and open contract pursuant to provisions of N.J.S.A.19:44A-20.5; and, WHEREAS, the Chief Financial Officer has determined and certified in writing that the value of the acquisitions will exceed \$17,500; and, WHEREAS, the anticipated term of this contract is one year; and, WHEREAS, ARDITO & CO., LLP has submitted a proposal, indicating they will provide the auditor services for the anticipated fee of \$24,297 (including court); and, WHEREAS, ARDITO & CO., LLP has competed and submitted a Business Entity Disclosure Certification which certified that ARDITO & CO., LLP has not made any reportable contributions to a political or candidate committee in the Township of Frelinghuysen in the previous one year, and that the contract will prohibit ARDITO & CO., LLP from making any reportable contributions through the term of the contract; and, WHEREAS, the required certificate for the availability of funds has been filed by the chief financial officer providing that legally appropriated balances are available to cover the amount of the contract as required by N.J.A.C. 5:30-14.5 and that fees for the aforementioned auditing and non-auditing services shall be made available by appropriate inclusion in either an annual municipal budget which includes current,

revenue sharing and utility provisions, by budget amendments for Federal program spending or by inclusion in an appropriate bond ordinance. NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Frelinghuysen, authorizes the Mayor and Clerk of the Township of Frelinghuysen to enter into a contract with ARDITO AND CO., LLP as described herein as auditors on and in behalf of the Township of Frelinghuysen for the year 2016; and, BE IT FURTHER RESOLVED that the Business Discloser Entity Certification and Determination of Value be placed on file with this resolution; and, BE IT FURTHER RESOLVED that a notice of this action shall be printed once in a legally designated publication. Political Contribution Disclosure. This contract has been awarded to Ardito & Co., LLP based on the merits and abilities of Ardito & Co., LLP to provide the goods and services as described herein. This contract was not awarded through a "fair and open" process pursuant to N.J.S.A. 19:44A-20.4 et seq. As such, the undersigned does hereby attest that Ardito & Co., LLP, its subsidiaries, assigns or principals controlling in excess of 10% of the company has neither made a contribution, that is reportable pursuant to the Election Law Enforcement Commission pursuant to N.J.S.A. 19:44A-8 OR 19:44A-16 in the one (1) year period preceding the award of the contract that would, pursuant to P.L. 2004, c.19. affect its eligibility to perform this contract, nor will it make reportable contribution during the term of the contract to any political party committee in the municipality if a member of that political party is serving in an elective public office of that municipality when the contract is awarded, or to any candidate committee of any person seeing in an elective public office of the municipality when the contract is awarded. 2016-11 APPOINTING RISK MANAGMENT CONSULTANT WHEREAS, the Township of Frelinghuysen (hereinafter "Local Unit") has joined the Statewide Insurance Fund (hereinafter "Fund"), a joint insurance fund as defined in N.J.S.A. 40A:10-36 *et seq.*; and; WHEREAS, the Bylaws require participating members to appoint a Risk Management Consultant, as those positions are defined in the Bylaws, if requested to do so by the "Fund"; and WHEREAS, the Local Unit has complied with relevant law with regard to the appointment of a Risk management Consultant; and WHEREAS, the "Fund" has requested its members to appoint individuals or entities to that position; and NOW, THEREFORE, BE IT RESOLVED by the governing body of the "Local Unit", in the County of Warren and State of New Jersey, as follows:

- Space Farms renew contract for one year term January 1, 2016-December 31, 2016. Mr. DeCarolis made a motion to approve said contract, seconded by Mr. Boynton. All were in favor.
- 3. Municipal Software Inc. (MSI) tabled. Mr. Boynton made a motion to table until the regular meeting, seconded by Mr. DeCarolis. All were in favor.
- PCFA renew contract for one year term January 1, 2016-December 31, 2016. Mr. Boynton made a motion to approve, seconded by Mr. Desiderio. All were in favor.
- 5. State wide Insurance tabled. Mr. Desiderio made a motion to table until the regular meeting, seconded by Mr. Boynton. All were in favor.

## **OPEN MEETING TO THE PUBLIC:**

Motion was made by Mr. Desiderio, seconded by Mr. Boynton to open meeting to the public. All were in favor. Spoke were:

• Hope Fire Department - inquired where they stand on their budget request. Mr. Kuhn explained the budget process and let them know a date would be set to attend a budget meeting. The Chief stated that fire coverage would end on January 15th as they are tired of not getting answers. The committee explained the budgeting process again to them and it was agreed that they would attend the work session to be held on January 13, 2016 at 6 pm. to go over their request. Ms. Zilberfarb will make sure that Ms. Dyer, CFO, will be in attendance for that meeting. Ms. Zilberfarb will also post Notice of the meeting time change with the news paper, post on the website and the bulletin board.

 Tammy Beckenthal - Asked if there were job descriptions available for the positions in town. Mr. Kuhn pointed her to the website for the Municipal Code Ordinance. Ms. Beckenthal also asked how copies of the Resolutions can be obtained. Mr. Kuhn informed her that they are printed in the approved minutes after each meeting and that she can also stop in the town hall to obtain a copy. Ms. Beckenthal then asked if there was a notary at the town hall. Ms. Zilberfarb explained that she is one. Ms. Beckenthal asked if there was an Alt#1 since she was just appointed as Alt#2 for the Historical committee. Sarah Kapitko is Alt #1.

Motion was made by Mr. Boynton, seconded by Mr. Desiderio to close to the public. All were in favor.

After public session, Mr. DeCarolis explained that he felt the new Foreman, Calvin Inscho, should be allowed to take the town truck home each night. Mr. Brady confirmed that the Employee Handbook has been updated and is ready for adoption from the committee.

Mr. Brady explained about the easement search that Sandy Urgo from TLC, is looking to obtain for Green Acres. He explained that for a title company to do the search it will be \$500 plus cost of copies. Arlene Maynards of Liberty Abstract can do this search.

Motion was made by Mr. Desiderio to authorize Mr. Wacks to complete the easement search for not more than \$500.00 plus copy costs, seconded by Mr. Boynton. All were in favor.

Mr. Brady explained that Ms. Greene will need to prepare a vacant land analysis for the COAH project and will need an authorization for her to complete with a cost up to \$3,000.00.

Motion was made by Mr. Boynton to authorize Darlene Greene up to \$3,000.00 for her work on the COAH case, seconded by Mr. Desiderio. All were in favor.

Mr. Boynton asked where the John Lotz sign needed to be placed and Mr. Desiderio will show him. Mr. Boynton informed that scaffolding will be up at the Kids Camp Lodge to look at and replace, if needed, the fire alarms.
