MINUTES OF MEETING OF MARCH 18, 2015

The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Main Street, Johnsonburg, New Jersey on Wednesday, March 18, 2015 and was called to order at 7:30 by Deputy Mayor Christopher Stracco.

Jackie Espinoza of JCP&L advised that there is work being done on circuits in the township. There is a 17% decrease in 2014 from 2013 for outages.

The Green Township Fire Dept letter regarding the standpipe and budget request is on hold. Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis to hold for the April meeting. All were in favor.

Service Electric Cable TV-Attorney David Brady advised that the concerns of the other townships are be addressed by the State. It was decided to wait and see what happens.

A letter thanking Mr. Benjamin Gerson for his donation of a conservation easement on two parcels of land totaling 31.033 acres on Mott Road was approved for the Mayor's signature on motion made by Mr. Boynton, seconded by Mr. Desiderio. All were in favor.

NEW BUSINESS:

Loren Greco asked the Committee who called the attorney to prepare the January 7th ordinances. Deputy Mayor Stracco told Mr. Greco that he did. The Mayor told Mr. Greco that he didn't want to rehash this anymore.

Safety at intersection of Route 661 and 519 is being tabled for the April 15th meeting.

Speed limit on Greendell Road is being tabled for the April 15th meeting.

Dr. Michael Tudor had a question for the attorney. He asked if there was any way the historical committee could analyze homes in disrepair and make low income rentals therefore meeting the required number for housing. He was told there is a 30 year deed restriction with no control over whom rents the houses.

Debra Natyzak asked if trailer parks were allowed to be counted for COAH as they would make good low income housing. She was told that most towns restrict these. Motion was made by Mr. Boynton, seconded by Mr. Stracco to close the meeting to the public. All were in favor.

Motion was made by Mr. Boynton, seconded by Mr. DeCarolis to table the department reports. Roll call vote: Mr. Stracco-yes, Mr. DeCarolis-yes, Mr. Boynton-yes, Mr. Kuhn-yes, Mr. Desiderio-left the meeting.

There being no further business, motion was made by Mr. Boynton, seconded by Mr. DeCarolis to adjourn the meeting. All were in favor.
