Witness my hand and the SEAL of the Township of Frelinghuysen. Donna Zilberfarb, Municipal Clerk. Motion was made by Mr. Stracco to open for second reading for adoption, seconded by Mr. Boynton. All were in favor. Motion was made by Mr. Stracco to open to the public, seconded by Mr. Boynton. All were in favor. Public: Dale Durling, Sr. inquired about the debt of the town being 2 million dollars. Ms. Dyer explained that the debt is all from Capital ordinances and gave an explanation as to what the \$285,000 is in the capital ordinance for this year. She also explained that the FFP (Kids Camp) was \$340,000 municipal portion of the acquisition, which was a total of \$900,000, and that gets funded out of the open space trust fund. Mr. Durling asked specifically what monies were being borrowed for the FFP this year. Ms. Dyer explained and let them know that \$110,000 was for a salt shed. Mr. Stracco gave the history of the salt shed. Mr. Durling stated that a lot of spinning wheels and getting nothing accomplished. He also stated to the committee to do the right thing and spend the money like it was their own. Discussion on the salt shed moving to Route 94 continued with Mr. Boynton stating that the road opening is not valid and will need to get another permit and that there is nothing on Route 94 and all equipment is housed here. Mr. Stracco stated that engineering has been done and to re-modify anything at the townhall would need to go through SHIPO for approvals, and there is a cost for those approvals. Mr. Desiderio explained that it made sense for a future garage from a while ago and that the garage has no septic and has to meet today's code. Mr. Marra explained they are taking small steps and are trying to move forward. Dan Kohuth stated with 2.2 million in debt, he asked what the other big items are for purchase this year. Ms. Dyer stated she would get him that information and to see the Clerk tomorrow for it. Mr. Stracco explained that this debt is 10 years worth of bonds including open space purchases and explained the budget process to the public. He also explained that the fire departments and ambulances come to the township for capital purchases as well. Mr. Kohuth supports the fire and ambulance departments and stated that FFP is a money pit and asked if it was currently our shelter? Mr. Desiderio answered that it has the bathrooms and showers and capability. Mr. Stracco gave a brief history on the purchase of Kids Camp and ultimately it was a win win for the township. Keith Ramos asked what the total cost of purchase was of kids Camp and Ms. Dyer stated \$943,000.00. Mr. Ramos asked what amount currently owed for FFP (Kids Camp) was. Ms. Dyer replied with \$261,297.00. Mr. Ramos also asked if the salt shed was repairable. Mr. Desiderio stated that it was not large enough and would need to be rebuilt. Motion was made by Mr. Stracco to close to the public, seconded by Mr. Boynton. Motion was made by Mr. Stracco to approve and adopt the 2019 budget, seconded by Mr. Marra. ORDINANCES:

#2019-02 ORDINANCE AMENDING SECTION 1003 OF THE FRELINGHUYSEN TOWNSHIP CODE REQUIRING SUBMISSION OF FOUNDATION LOCATION SURVEY IN CERTAIN INSTANCES WHEREAS, the Frelinghuysen Township Mayor and Committee have determined that a foundation location survey is necessary and appropriate to assure that buildings are located within their approved envelopes before construction is completed, and good cause

having been shown. NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey as follows:

<u>Section I</u> Section 1003B of the Frelinghuysen Township Code is amended by adding thereto a new subsection 4 to read as follows:

- 4(a). A foundation location survey, signed and sealed by a licensed land surveyor, shall be submitted to the Township Engineer prior to the framing of any building. The Township Engineer shall report to the Department of Community Affairs within seven days of receipt of the foundation location survey if the foundation, as shown on the survey, was not constructed at the location and elevation approved by the Township Engineer.
- (b). An as-built drawing shall be submitted to the Township Engineer for review, unless waived by the Township Engineer. The Township Engineer shall report to the Department of Community Affairs within fifteen days of the receipt of the as-built drawing that the work has been completed in accordance with the grading plan.

Section II

- 1. All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.
- 2. If any word, phrase, clause, section or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.
- This ordinance shall take effect immediately upon final passage and publication as required by law. **NOTICE** Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading at the regular meeting of the Frelinghuysen Township Committee held on February 20, 2019 and will be considered for final reading and adoption at the meeting of the Frelinghuysen Township Committee to be held on March 20, 2019 at the Municipal Building, 210 Main Street, Johnsonburg, New Jersey at which time and place all interested parties may appear for or against the passage of said Ordinance. #2019-03 BOND ORDINANCE PROVIDING FOR VARIOUS 2019 CAPITAL IMPROVEMENTS, BY AND IN THE TOWNSHIP OF FRELINGHUYSEN, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY; APPROPRIATING \$285,650 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$271,350, BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF FRELINGHUYSEN, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS: SECTION 1. improvements or purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements or purposes to be undertaken by the ownship of Frelinghuysen, in the County of Warren, State of New Jersey (the "Township"). For the said improvements or purposes stated in Section 3, there is hereby appropriated the sum of \$285,650, said sum being inclusive of a down payment in the amount of \$14,300 now available for said improvements or purposes required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq., as amended and supplemented (the "Local Bond Law"), and now available therefor by virtue of a provision or provisions in a previously adopted budget or budgets of the Township for down payment or for capital improvement purposes. SECTION 2. For the financing of said improvements or purposes described in Section 3 hereof and to meet the part of said \$285,650 appropriation not provided for by the down payment referred to in Section 1 hereof, negotiable bonds of the Township are hereby authorized to be issued in the principal amount of \$271,350 pursuant to the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of

the Township in a principal amount not exceeding \$271,350 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law. SECTION 3. (a) The improvements hereby authorized and purposes for the financing of which said bonds or notes are to be issued is the 2019 Capital Improvement Program, which includes, but is not limited to: (i) the acquisition of a blacktop roller machine, a brush hog lawnmower and a new bed for a Ford pickup truck; (ii) the acquisition and installation of new carpeting and flooring in the Town Hall; (iii) the acquisition of a thermal imaging camera, rescue equipment, hose and turnout gear for use by the Green Township Fire Department; (iv) the acquisition of turnout gear and extrication equipment for use by the Blairstown Fire Department; (v) the acquisition of turnout gear and selfcontained breathing apparatus (scba) bottles for use by the Hope Fire Department; (vi) the acquisition of a flammable storage cabinet for the Department of Public Works ("DPW") garage; (vii) the acquisition of various tools, including, but not limited to, an impact gun, wrenches and sockets for use by the DPW; (viii) the acquisition and installation of a salt shed; (ix) the installation of dugouts for the Recreational Field; (x) repairs and improvements to various roads within the Township, including, but not limited to, paving, cross drains, tarring and chipping; (xi) the design and development of the Township's website; and (xii) he demolition of an abandoned barn located on municipal property and considered a health hazard, including, as applicable, all work, materials, equipment, labor and appurtenances necessary for or incidental to all of the above described improvements and purposes, all in accordance with the plans therefor on file in the office of the Township Clerk and available for public inspection and hereby approved. (b) The estimated maximum amount of bonds or notes to be issued for said improvements or purposes is \$271,350. (c) The estimated cost of said improvements or purposes is \$285,650, the excess thereof over the estimated maximum amount of bonds or notes to be issued therefor being the amount of \$14,300, which is the down payment available for such improvements or purposes. SECTION 4. In the event the United States of America, the State of New Jersey, and/or the County of Warren make a contribution or grant in aid to the Township for the improvements and purposes authorized hereby and the same shall be received by the Township prior to the issuance of the bonds or notes authorized in Section 2 hereof, then the amount of such bonds or notes to be issued shall be reduced by the amount so received from the United States of America, the State of New Jersey and/or the County of Warren. In the event, however, that any amount so contributed or granted by the United States of America, the State of New Jersey and/or the County of Warren shall be received by the Township after the issuance of the bonds or notes authorized in Section 2 hereof, then such funds shall be applied to the payment of the bonds or notes so issued and shall be used for no other purpose. SECTION 5. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Township, provided that no note shall mature later than one (1) year from its date or as otherwise authorized by the Local Bond Law. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the signature of the Chief Financial Officer upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time in accordance with the provisions of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, the description, the interest rate, and the maturity schedule of the notes so sold, the price obtained and the name of the purchaser. SECTION 6. The Capital Budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs will

be on file in the office of the Clerk and will be available for public inspection. SECTION 7. The following additional matters are hereby determined, declared. recited and stated: (a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses and are improvements which the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby. (b) The average period of usefulness of said improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the said bonds authorized by this bond ordinance, is 11.92 years. (c) The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Township and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, and such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds or notes provided for in this bond ordinance by \$271,350 and the said bonds or notes authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law. (d) An aggregate amount not exceeding \$3,000 for items of expense listed in and permitted under Section 20 of the Local Bond Law is included in the estimated cost indicated herein for the improvements or purposes hereinbefore described. SECTION 8. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the bonds or notes authorized by this bond ordinance. The bonds or notes shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the bonds or notes and the interest thereon without limitation as to rate or amount. SECTION 9. The Township reasonably expects to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 of this bond ordinance and paid prior to the issuance of any bonds or notes authorized by this bond ordinance with the proceeds of such bonds or notes. No funds from sources other than the bonds or notes authorized herein have been or are reasonably expected to be reserved, allocated on a long-term basis or otherwise set aside by the Township, or any member of the same "Controlled Group" as the Township, within the meaning of Treasury Regulation Section 1.150-1(e), pursuant to its budget or financial policies with respect to any expenditures to be reimbursed. This Section 9 is intended to be and hereby is a declaration of the Township's official intent to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 hereof to be incurred and paid prior to the issuance of bonds or notes authorized herein in accordance with Treasury Regulation Section 1.150-2, and no further action (or inaction) will be an abusive arbitrage device in accordance with Treasury Regulation Section 1.148-10 to avoid the arbitrage yield restrictions or arbitrage rebate requirements under Section 148 of the Internal Revenue Code of 1986, as amended (the "Code"). The proceeds of any bonds or notes authorized herein used to reimburse the Township for any expenditures toward the costs of the improvements or purposes described in Section 3 hereof will not be used directly or indirectly (i) to "refund" an issue of governmental obligations within the meaning of Treasury Regulation Section 1.150-1(d), (ii) to create, within one year, following the reimbursement of any expenditures of bond proceeds "replacement proceeds" within the meaning of Treasury Regulation Section 1.148-1 of the bonds or any other bond issue, or (iii) to reimburse the Township for any expenditure or payment that was originally paid with the proceeds of any obligation of the Township (other than borrowing by the Township from one of its own funds or the funds of a member of the same "Controlled Group" within the meaning of Treasury Regulation Section 1.150-1(e)). The bonds or notes authorized herein to reimburse the Township for any expenditures toward the costs of the improvements or purposes described in Section 3 hereof will be issued in an amount not to exceed \$271,350. The costs to be reimbursed with the proceeds of the bonds or notes authorized herein will be "capital expenditures" in accordance with the meaning of Section 150 of the Code and Treasury Regulation Section 1.150-1. This provision will take effect immediately, but will be of no effect with regard to expenditures for costs paid outside the permitted reimbursement period set forth in Treasury Regulation Section 1.150-2(d)(2). SECTION 10. The Township covenants to maintain the exclusion from

gross income under Section 103(a) of the Code of the interest on all bonds and notes issued under this ordinance. SECTION 11. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law. Motion was made by Mr. Boynton to open for introduction, seconded by Mr. Marra. Roll Call vote: Mr. Boynton-yes; Mr. Desideiro-yes; Mr. Marra-yes; Mr. McPeek-yes; Mr. Stracco-yes. Second reading for adoption will be held on March 20, 2019 at 7:30 p.m. Motion was made by Mr. Stracco to open for second reading for adoption, seconded by Mr. Boynton. All were in favor. Motion was made by Mr. Stracco to open to the public, seconded by Mr. Boynton. All were in favor. Public: Mr. Kohuth asked what the final allotment for the salt shed was. Ms. Dyer stated \$110,000. Mr. Kohuth asked what has been looked into for that amount. Mr. Desiderio explained that they are looking for one that holds 1200 tons. Mr. Kohuth asked about a runoff system and Mr. Desiderio explained that the engineering has not been finalized at this time. Mr. Durling asked about electricity at the new location and Mr. Desiderio stated that yes there would need to be electric. Mr. Kohuth inquired about the roller for \$19,000.00 and asked how many days it is used per year. Mr. Desiderio explained that renting was not an option and use it 45-50 days all throughout the year to patch the roads. Mr. Kohuth stated renting a roller would be more frugal at \$300 to \$500 per day. Howard Solomon stated that in 2 years it will pay for itself and renting wasn't the way to look at it. Mr. Kohuth also mentioned the dugouts for \$6,000.00 and Mr. Desiderio explained the new rules for children and having dugouts. Mr. Ramos stated he could have gotten the dug outs donated and Marty Connor asked if the recreation committee considered asking the booster club to pay for them. Mr. Ramos explained that they did but it was the initiative of the recreation committee to put in the dugouts. Mr. Connor asked what was spent on road repair last year. Ms. Dyer stated none. Sarah Hergert stated that Greendell Road needed repairs and asked if anything would be done. Ms. Zilberfarb explained that the township is in the process of obtaining a grant to pave that road and haven't heard back as to whether we received the funding yet. She stated that it would be patched in the interim. Fran Muller asked if it would be just a salt shed or would trucks be parked at the site and also asked about the signs for the auction and if there are any substitutes for salt being used. Mr. Desiderio explained signs were posted in the wrong spot for the auction and that it would be just the salt shed. Mr. Kohuth asked about the \$15,000 for the demo at the FFP and asked what is being demolished. Mr. Desiderio explained the history of the boat house/barn and that is in the process of being looked at as being historic. Mr. Lance asked if it is savable, will that \$15,000 be rolled into repairs? Ms. Dyer stated that the ordinance would need to be amended. Motion was made by Mr. Stracco to close to the public, seconded by Mr. Boynton. All were in favor. Motion was made by Mr. Stracco to approve for adoption, seconded by Mr. Boynton. Roll call vote: Mr. Boynton-yes; Mr. Desiderio-yes; Mr. Marra-yes; Mr. McPeek-yes; Mr. Stracco-yes.

#2019-04 ORDINANCE AMENDING SECTION 7-3.7 OF THE FRELINGHUYSEN TOWNSHIP CODE PROHIBITING PARKING ON SNOW-COVERED STREETS WHEREAS, the

Frelinghuysen Township Code presently prohibits parking on certain Township streets when there are more than two inches of snow on the ground; and WHEREAS, the Frelinghuysen Township Mayor and Committee have determined that it serves the public health, safety and welfare to prohibit parking on all Township streets when there are more than two inches of snow on the ground, and good cause having been shown.
