5. ELECTION OF THE CHAIR. Motion was made by Mr. Stracco, seconded by Mr. Walters to nominate Mr. Jungkind. Mr. Jungkind declined. Mr. Jungkind made a motion to nominate Mr. Stracco. Mr. Stracco advised he could not be the Chair as he is the Mayor's designee. Mr. Jungkind made a motion to nominate Ms. Eitner. Seconded by Mr. Walters. Mr. DeCarolis made a motion to nominate Mr. Soisson, seconded by Ms Randolph. At this time a straw vote was taken with Mr. Soisson receiving the majority of the votes, however, the acting secretary turned the Chair over to Ms. Eitner and took the Vice Chair position.
