The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Main Street, Johnsonburg, New Jersey on Wednesday, May 18, 2016 and was called to order at 7:30 p.m. by Mayor, Christopher Kuhn.

SUNSHINE LAW STATEMENT:

Under the provisions of the Open Public Meetings Act, adequate notice of this meeting was provided by posting notice on the Township bulletin board and by e mailing notice to the New Jersey Herald and The Express-Times.

ROLL CALL:

Those present were: Mayor Christopher Kuhn, Deputy Mayor Christopher Stracco, Committeeman Boynton, Committeeman Frank Desiderio, Committeeman Alan DeCarolis, and Acting Clerk Donna Zilberfarb.

PRESENTATIONS:

Sara Bilotti and Chris Hagel from North Warren High School presented the budget for the school and explained the savings for Frelinghuysen. They discussed student performance, programs, enrollment and budget facts. Discussion and questions were raised by members of the audience and were answered. Mr. Kuhn thanked Mr. Hagel and Ms. Bilotti for their attendance and their presentation.

production in Frelinghuysen Township, and said tract falls within a predetermined Agricultural Development Area and is adjacent to other preserved farms; and WHEREAS, the pressures from development have significantly heightened the degree of imminence of change of land use from productive agriculture to nonagricultural uses; and WHEREAS, the State Agricultural Development Committee has certified the fair market value of said farm; and WHEREAS, a contract for \$4,400 per acre with the landowners is anticipated with an estimated total value of \$179,124, the exact compensation to be determined by a final survey; and WHEREAS, the Township is authorized to provide funding up to 15.5% of the purchase price (or \$680 per acre of the easement) to be paid from the Township's Open Space Trust, contingent on receiving a signed contract from the landowner. **NOW THEREFORE BE IT RESOLVED**, by the Committee of the Township of Frelinghuysen as follows: The Committee of the Township of Frelinghuysen hereby supports the purchase of a development easement on Post Farm under the Township's Municipal Planning Incentive Grant Farmland Preservation program, in partnership with the County of Warren and the State Agriculture Development Committee. OLD BUSINESS:

Community Service Award - Mr. Kuhn asked the Committee members for their thoughts on who should receive the community service award this year. After discussion, a motion was made by Mr. Boynton, seconded by Mr. Stracco to nominate Charles and Fran Muller. All were in favor.

The Mill on Mill Road update - Ms. Bisilicato presented the township with a print of the old train station to be hung in the town hall. She also asked about the work to be done on the old mill and when it would begin. She also inquired as to who makes the Ordinances in town and why isn't there a maintenance one. Mr. Boynton clarified that the owner of the mill has building permits for the work to be done. A copy of the letter from the restoration group in regards to the work on the mill was given to Ms. Bisilicato stating that work will commence soon. They were at the site on 5/13/16. Ms. Bisilicato also asked if Mr. DeCarolis if he had gone out to look at the tree she spoke of that is laying close to road. Mr. DeCarolis also mentioned that we will be chipping debris along the roads in the fall. Mr. Stracco thanked her for the print.

NEW BUSINESS:

Jackie Espinoza of JCP&L discussed power outages and stated that the trimming of the trees have been completed for Frelinghuysen Township. Ms. Espinosa answered questions regarding the presentation at the work session meeting. She explained that JCP&L stays out of that and has no opinion on it. JCP&L still provides the service.

Tax sale - Natures Conservancy - Block 1201 Lots 29, 29.01 and 37. After discussion, a motion was made by Mr. Desiderio to authorize Ed Wacks to proceed with in rem tax sale foreclosure, seconded by Mr. Stracco. All were in favor.

Master Plan - Darlene Green of Maser Consulting will be doing the work to update the master plan. A contract was presented to the committee for moving forward with a cost of \$6,250.00. A motion was made by Mr. Desiderio to approve the contract for \$6,250.00, seconded by Mr. Boynton. All were in favor.

Fair Share Housing Act - Mr. Wacks explained in detail what this means for the Township of Frelinghuysen and how it affects COAH. Mr. Wacks handed out a letter to be sent to the Legislators in regards to the gap period. Ms. Zilberfarb will send the letter out to list given.

OPEN MEETING TO THE PUBLIC:

Motion was made by Mr. DeCarolis, seconded by Mr. Stracco to open meeting to the public. All were in favor. Spoke were:

Mr. Marra spoke regarding the State giving monies to Kids Camp but not having COAH housing. He asked if they could take the property. Mr. Wacks explained that the monies received were specifically for that property and there is a very slight chance that would happen.

Marty Connor spoke regarding an Ordinance regarding the FFP rules and regulations that was to be done according to the minutes in September but didn't believe it was completed. Mr. Wacks will look into and get a report back. Mr. Connor also asked about opening the camp and asked if there were any legal issues. Mr. Wacks discussed that as long as the committee feels comfortable they can open. Ms. Natyzak discussed that it shouldn't be opened as there is no one to police or manage it. Mr. Kuhn explained that Mr. Connor and Ms. Buttgereit manage the property.

Debra Natyzak spoke regarding the change of use for the kids camp property and asked why the change. Ms. Buttgereit stated it is just for the lodge.

Dan Kohuth inquired what the road department consisted of. Mr. Kuhn explained, Mr. Harman is the Foreman, Ms. Zilberfarb is the Supervisor and Mr. Pitalla is a part time Laborer. Mr. Kohuth also asked about the salt shed. After discussion, Mr. Kuhn explained all the different options and how the plan for the new salt shed came to be. Discussion from audience as to where the new salt shed would go and if the septic system has been considered.

Joyce Pinho asked if the residents have any say in the cost of this salt shed.

Loren Greco asked if it was true that the cost spent to date was \$21,000.00. Mr. Kuhn responded yes.

Charlie Marra asked if anyone approached the state to do a shared services for salt storage. He also asked why can't they leave it where it is but move back a bit into the mountain and clear the area to have tables so the families can see all the fields at once.

Mr. Desiderio handed to all members copies of a petition signed by approximately 80+ residents asking this to be put on the ballot as a question.

Motion was made by Mr. Desiderio, seconded by Mr. Stracco to close meeting to the public. All in favor - Mr. Kuhn opposed.

New Business Continued:

Motion was made by Mr. Desiderio for approval for the COAH gap to send the letter to the Legislators, seconded by Mr. Boynton. All were in favor.

Motion was made by Mr. Desiderio to table the opening of Kids Camp, seconded by Mr. DeCarolis. All were in favor.

Motion was made by Mr. Desiderio directed from Recreation that a new salt shed should not be built in the parking lot and should be placed on the ballot in November, seconded

There was no second. Motion denied.

Motion was made to table the salt shed, seconded by Mr. Boynton. All were in favor. Mr. DeCarolis opposed.

DEPARTMENT REPORTS:

Motion made by Mr. DeCarolis for consent agenda items 1-10, seconded by Mr. Boynton. All were in favor.

FFP - Mr. Connor stated that all plumbing has been completed.

Mr. Boynton discussed some issues regarding Kids Camp and work that has been done thus far. He publicly stated that he was thrown under the bus and is bothered by it. He stated that he will no longer do any work for free anymore. When something needs to be taken care of the township will need to hire someone to do it from now on.

Ms. Zilberfarb asked if the Mullers could enlarge the 911 map. Motion was made by Mr. Desiderio to make the map larger, seconded by Mr. DeCarolis. All were in favor.

Recreation - Founders Day is June 4th. Mr. Desiderio discussed the dunk tank that the PTO wanted to have and stated that it was not going to be at this event this year.

Mayor report - Mr. Kuhn discussed continuing on the energy aggregation for information. Work on the maple syrup ordinance continues and would like to invite Mr. Kapitko to the next meeting. He also explained that there is no ANJEC grant funding this year.

Deputy Mayor report - Discussed the Land Use Board and the Master Plan update being worked on.

Committeman Boynton report - Asked to hire someone to paint the exterior of the lodge and to hire someone to install the John Lotz sign at the field at the town hall. Mr. Desiderio stated that the Recreation booster club will pay for the sign to get put up.

Committeeman Desiderio – nothing to report at this time.

Committeeman DeCarolis – nothing to report at this time.

Clerk report - Ms. Zilberfarb discussed that the storm jonas paperwork has been filed with FEMA for reimbursement. She also stated that all financial disclosures were filed for 2016. Ms. Zilberfarb discussed the classes that were taken and the CEU credits earned for each class. A safety meeting with the insurance company representative, Ivan Cohen was held and after discussion, a few minor issues need to be taken care of.

ADJOURNMENT:

There being no further business, motion was made by Mr. Desiderio, seconded by Mr. Stracco to adjourn the meeting at 10:45 p.m. All were in favor.
