MINUTES OF THE MEETING OF MAY 20, 2015

The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Main Street, Johnsonburg, New Jersey on Wednesday, May 20, 2015 and was called to order at 7:00 p.m. by Mayor Christopher Kuhn.

SUNSHINE LAW STATEMENT:

Under the provisions of the Open Public Meetings Act, adequate notice of this meeting was provided by posting notice on the Township bulletin board and by e mailing notice to the New Jersey Herald and The Express-Times.

ROLL CALL:

Those present were: Mayor Christopher Kuhn, Deputy Mayor Christopher Stracco, Committeeman Frank Desiderio, Committeeman Alan DeCarolis, Committeeman David Boynton, Attorney Edward Wacks and Deputy Clerk Brenda Kleber.

EXECUTIVE SESSION:

Motion was made by Mr. Boynton, seconded by Mr. DeCarolis to enter into executive session with regard to potential litigation and property acquisition after resolution #2015-53 was adopted in the public portion of the meeting. All were in favor. Motion was made by Mr. Stracco, seconded by Mr. Boynton to return to the public meeting. All were in favor. Upon returning, Mr. Wacks stated that in closed session the discussion was on some property acquisition that the township is currently seeking. The financing was also discussed and resolution dealing with respect to the funding will be presented later. The other matter is that there is potential litigation as a result of activity on South Street and should that continue to occur the committee gave the attorney the approval to take whatever legal actions are necessary.

PUBLIC HEARING ON BUDGET:

Municipal auditor Anthony Ardito stated that the 2015 budget will increase by \$1.58 which equates to \$53.00 a year on a house assessed at \$335,000.00

There being no public input, motion was made by Mr. DeCarolis, seconded by Mr. Boynton to close to the public. All were in favor. #2015-49 (Budget adoption)

WHEREAS, N.J.S.A.40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and,

WHEREAS, N.J.A.C.5:30-7 was adopted by the Local Finance Board on February 11, 1997; and,

WHEREAS, pursuant to N.J.A.C.5:30-7.2 thru 7.5 the Township of Frelinghuysen has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township of Frelinghuysen meets the necessary conditions to participate in the program for the 2015 budget year, so now therefore,

BE IT RESOLVED, by the Township Committee of the Township of Frelinghuysen that in accordance with N.J.A.C.5:30-7.6a & b, and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A.40A:45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with the "CAP" law.)
- 3. That the budget is in such form, arrangement and content as required by the Local Budget Law and N.J.A.C.5:30-4 and 5:30-5.4.
- 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated;
 - b. Items of appropriation are properly set forth;
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
 - 5. The budget and associated amendments have been introduced, publicly advertised and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A.40A:4-5, shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Director of the Division of Local Government Services.

WHEREAS, Resolution #2015-48 was adopted by the Mayor and Township Committee at the work meeting of May 13, 2015 resulting in granting approval of the purchase of the development easement on Shiloh Hill Farm; and

WHEREAS, the SADC informed the Mayor and Township Committee after resolution #2015-48 was adopted that additional information must be added to the resolution.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Township Committee of the Township of Frelinghuysen that resolution #2015-48 be rescinded and a new resolution will be prepared (see resolution #2015-51).

#2015-51 (Granting approval of purchase of development easement)

WHEREAS, the Committee of the Township of Frelinghuysen has determined that the property known as Shiloh Hill Farm, Block 1803, Lot 8.01 & B1804 / L5 & L6 in Frelinghuysen Township, consisting of approximately 106.21 acres to be preserved, is available for purchase of a development easement in accordance with the requirements of the farmland preservation programs; and

WHEREAS, preservation of this land would encourage the survivability of agricultural production in Frelinghuysen Township, and said tracts fall within a predetermined Agricultural Development Area; and

WHEREAS, the pressures from development have significantly heightened the degree of imminence of change of land use from productive agriculture to nonagricultural uses; and

WHEREAS, the State Agricultural Development Committee has certified the fair market value of said farm; and

WHEREAS, a contract for \$5,750 per acre with the landowners is anticipated with an estimated total value of \$609,500, the exact compensation to be determined by a final survey; and

WHEREAS, the Township is authorized to provide funding up to 17.17% of the purchase price (or \$987.50/acre of the easement) to be paid from the Township's Open Space Trust, contingent on receiving a signed contract from the landowner.

NOW THEREFORE BE IT RESOLVED, by the Committee of the Township of Frelinghuysen as follows:

The Committee of the Township of Frelinghuysen hereby supports the purchase of a development easement on Shiloh Hill Farm under the Township's Municipal Planning Incentive Grant Farmland Preservation program, in partnership with the County of Warren and the State Agriculture Development Committee.

OLD BUSINESS:

The Mayor announced that he will award the first annual Community Service Award to Wendy Buttgereit. Motion was made by Mr. Desiderio, seconded by Mr. Boynton concurring with the Mayor nomination. All were in favor.

The Recreation Committee recommended that the Township Committee give a warning to dog owners who take their dog on the ballfields. The coaches have been made aware that dogs aren't allowed. 8 additional signs will be ordered.

Recreation Chairman Frank Desiderio advised the attorney of a scoreboard sign he would like to put up in the ballfield with John Lotz name. The attorney thought it was a great idea and he will issue a check in Mr. Lotz's memory to the township.

The discussion on the placement on a new salt shed incurred. The survey that was done on the DPW garage property showed that there wasn't enough room for a salt shed. The property on Route 94 has wetlands and will impact the COAH issues. The proposal now is to place it on the town hall property in the location where the portable facility is now. The engineer will look into approval from SHPO. The Township Committee will meet with the Land Use Board on May 4th for a curiosity review.

NEW BUSINESS:

The Deputy Clerk advised that no bids were received on the Municibid web site for the John Deere tractor door or the pool supplies. There was a bid in the amount of \$50.00 for the chairs. Motion was made by Mr. DeCarolis, seconded by Mr. DeSiderio to accept the \$50.00 bid for the chairs. All were in favor. Motion was made by Mr. DeCarolis, seconded by Mr. Boynton to put the pool supplies on Craigslist. All were in favor.

A request from North Warren Regional School requesting that we adjust our dates for the July, August and September tax levy payments due to their budget being cut and their surplus being low they need the cash flow was denied on motion made by Mr. Desiderio, seconded by Mr. DeCarolis. All were in favor.

An agreement between Valley Medical group and the Township to provide alcohol and drug testing on the DPW workers was tabled to the next meeting.

At the Mayor's meeting, it was mentioned that the State Police Barracks in Hope doesn't have any security cameras around the outside of the building. By working with Clean Communities a donation could be made towards the camera in the amount of \$250.00. The Mayor will discuss further with the Clean Communities Coordinator. Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis approving the donation in the amount of \$250.00 if Clean Communities gives their approval. All were in favor.

Representatives from the local fire departments were in attendance asking for additional funds as their budgets are increasing. The Mayor asked that in the future they come to a meeting in January instead of waiting for the month that the budget was adopted. They will also come up with the number of houses per fire company and a funding formula will be used to come up with a fair donation. Mr. Wacks mentioned that Allamuchy Township has an ordinance called "cash for crash" which is designed to obtain "reimbursement of expenditures' incurred in connection with fire department and emergency medical services. Mr. Wacks will prepare an ordinance for the next meeting.

The Mayor appointed Sarah Kapitko as alternate #2 to the Environmental Commission. Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis concurring with the Mayor's appointment. All were in favor.

OPEN MEETING TO THE PUBLIC.

Motion was made by Mr. DeCarolis, seconded by Mr. Boynton to open the meeting to the public. All were in favor. Spoke were:

Jenna Gajdek who stated that the drain doesn't catch the water from the driveway across the street and floods her basement. Mr. DeCarolis will take care of this.

Michael Tudor asked if we could get a grant from Sustainable Jersey for the fire department. Mr. DeCarolis will look into this.

Loren Greco asked what PERS is. He was told it was Public Employees Retirement Service.

Motion was made by Mr. Boynton, seconded by Mr. DeCarolis to approve the department reports 1-11 on a consent agenda motion. All were in favor.

Recreation Committee-June 6th is Founders Day. PTO is putting up a Dunk Tank to raise funds for the 6th grade class.

Emergency Management Coordinator-no report

Environmental Commission- Mr. DeCarolis met with Hope Township on Sustainable Jersey. He will discuss further at the next environmental commission.

Mayor Kuhn-no report Deputy Mayor Stracco-no report

Mayor Kuhn asked whether Tri State had been paid for the accident health insurance. He explained that Statewide would match the same amount of coverage as Tri State for \$600.00.

Committeeman David Boynton-was approached by a resident on Main Street who would like the committee to purchase his property. This will be discussed at a later date.

Committeeman Alan DeCarolis-had a cat found on Main Street tested for rabies which was found to be negative.
