MINUTES OF MEETING OF AUGUST 20, 2014

The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Main Street, Johnsonburg, New Jersey on Wednesday, August 20, 2014 and was called to order at 7:35 p.m. by Mayor David Boynton.

Ms. Goetz stated that since the buildings are old will there be any extra cost to take them down. She was told that there will be cost but is unknown at this time. Mr. Greco asked where the funds were coming from to take these buildings down and was told from the Open Space account. WHEREAS, a contract for sale of real estate for Kids Camp, Block 104, Lot 10 requires the Mayor and Municipal Clerk to sign; and

OLD BUSINESS:

Township Engineer Paul Sterbenz reported to the Committee on the following items: 1) State Park Road phase 4 received \$150,000 in discretionary aid. We will have 24 months to award the contract plus an additional 6 month extension. Spec will have to be put together. 2) the 2015 municipal aid for NJDOT needs to be done by October 14th.

The Committee needs to determine if they would like to apply and if so what road. It was decided that they will apply for Kerrs Corner Road phase 3 again. 3) South Street project has been completed and has been done very well. Final invoices will need to be submitted to close out the loan.

The revised proposal for professional engineering services to prepare plans and a permit application so that the Township can obtain the requisite NJDOT approvals to construct an access driveway to service a future public works facility on Block 201, Lot 31 in the amount of \$9,200.00 (less \$1,700.00) was approved on motion made by Mr. Desiderio, seconded by Mr. Kuhn. Roll call vote: Mr. Kuhn-yes, Mr. DeCarolis-no, Mr. Desiderio-yes, Mr. Stracco-yes, Mr. Boynton-yes.

NEW BUSINESS:

A memo from CFO Danette Dyer was read where she would like to implement a procedure where employees can contact her to request a purchase order/voucher in order to tighten up purchasing procedures by contacting her before any purchases. The Committee was in favor of this procedure.

OPEN MEETING TO THE PUBLIC:

Motion was made by Mr. Kuhn, seconded by Mr. DeCarolis to open the meeting to the public. All were in favor. Spoke were:

Jenny Lester who asked where the driveway was going on the Route 94 property. She was told it was going near the hedge row where there is no corn planted.

Art Lizza who asked there was an overview of the towns plan. He was told there would be one in the future.

Jenny Lester stated that there is a curve in the road near that location which is dangerous.

Art Lizza asked what kind of commercial use is in this area. He was told that it is AR6 zone at this time but may be changed to a NC/PO zone in the near future.

Wendy Goetz asked how large does the property have to be for a truck turn around and asked the size of the building. She was told that we will be going out for bids on the building shortly.

Motion was made by Mr. Kuhn, seconded by Mr. Desiderio to close the meeting to the public. All were in favor.

DEPARTMENT REPORTS:

Motion was made by Mr. DeCarolis, seconded by Mr. Desiderio to approve the department reports 1-9 on a consent agenda motion. All were in favor.

Recreation Committee-soccer is going great. Will be doing a "squirt" program for the younger children and is looking into a new playground.

Environmental Commission-There will be events scheduled for later in the year for the FFP property.

Open Space & Farmland Preservation-no meetings. But is looking into merging the two committees.

Mayor David Boynton-The Mayor thanked Mr. Desiderio for getting State Park Road repairs started. He received a note from Mr. Lurz on South Street who thanked him for the completion of the drainage issues. His painting crew will power wash the municipal building and stain the wood deck.

Deputy Mayor Christopher Kuhn-The Deputy Mayor reported that he met with the CFO and the budget will be tight until the end of the year. He also went over the potential shortages with her.

Committeeman Frank Desiderio-Mr. Desiderio went over the items needed for the proposed salt shed. He will be going out for bids on this shortly. He mentioned that he reached out to the company who is working on the power lines for quarry process and will be used for rebuilding Kerr Road along with using it on the Route 94 property. Motion was made by Mr. Kuhn, seconded by Mr. DeCarolis approving Mr. Desiderio offering up to \$50.00 a load, if any cost, for the quarry process. All were in favor with Mr. Desiderio abstaining.

Committeeman Christopher Stracco-Mr. Stracco asked Mr. Desiderio when the cracks will be filled on Saddle Ridge Road. He was told that the Mayor needs to mark out the cracks that need to be filled.

Committeeman Alan DeCarolis-Mr. DeCarolis thanked the Mayor for the power washing and staining of the municipal building.

EXECUTIVE SESSION:

Motion was made by Mr. Kuhn, seconded by Mr. DeCarolis to enter into executive session with regard to contract negotiations. All were in favor. Motion was made by Mr. Kuhn, seconded by Mr. Desiderio to return to public session. All were in favor. Upon returning Mr. Brady reported that the contract for Kids Camp is in final form and ready for the Mayor and Clerk to sign.
