## **MINUTES OF MEETING OF OCTOBER 23, 2013**

The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Main Street, Johnsonburg, New Jersey on Wednesday, October 23, 2013 and was called to order at 7:30 p.m. by Mayor David Boynton.

#### **SUNSHINE LAW STATEMENT:**

Under the provisions of the Open Public Meeting Act, adequate notice of this meeting was provided by posting notice on the Township bulletin board and by e mailing notice to the New Jersey Herald and The Express-Times. Note: The meeting was moved to the 23<sup>rd</sup> due to the special senate election held on October 16, 2013.

## **OLD BUSINESS:**

There was a question on why the no parking within 100' road sign was placed where it is as the sign is more than the 100' away. After discussion it was decided to leave as is.

The question of to whom the letter for stating our opposition to the school formula should sent to was asked of the attorney. There were some questions on what should be in the letter and background was needed before the letter could be drafted. Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis instructing the Clerk to OPRA the school formula from the North Warren Regional School, County Superintendent and the New Jersey Board of Education. Once the information has been received approval was given for Mr. Stracco and Mr. Wacks to draft a letter. All were in favor.

Mr. & Mrs. John Unangst came before the Committee on the South Street drainage easement agreement. They were uncomfortable with the wording and asked why the easement doesn't start at the top of the pond instead at the Lurz property and why his property is the only driveway with this easement. After the attorney explained to Mr. & Mrs. Unangst satisfaction the agreement was signed. It was asked that a 24 hour notice be given to the three affected landowners.

Mr. David Hocking and Mr. Tim Pender came before the Committee complaining about the hours of the rock removal company. The company is starting work by 5:30 am and is creating a lot of noise with the dropping of rocks into the truck bed. It was decided to change the hours and remove a section of the ordinance (see ordinances #2013-13 and #2013-14).

### **NEW BUSINESS:**

Proposals for the drainage work on South Street were received from All Terrain Excavating in the amount of \$18,800.00 and from Dabor Excavating in the amount of \$21,750.00. It was decided that the work would be done in house. A letter informing the two companies of the decision will be sent.

A letter from the Frelinghuysen Building Inspector asking for the Committee's thoughts on issuing a zoning permit for all stand by generators was referred to the Land Use Board for their input.

Due to four members of the committee attending the New Jersey State League of Municipalities conference on November 20<sup>th</sup> the regular meeting will need to be rescheduled. It was decided to hold the meeting on Monday November 18<sup>th</sup>.

Dan Carson appeared before the Committee to ask that the ordinance on outdoor wood burning stoves be reviewed. Mr. Carson would like to put in a wood burner but has a problem with the location and feels there should be exceptions for large property owners. This will be reviewed by the Land Use Board.

#### **OPEN MEETING TO THE PUBLIC:**

Motion was made by Mr. DeCarolis, seconded by Mr. Desiderio to open the meeting to the public. Spoke were:

Jean Smolha who asked what type of generators the building inspector was referring to.

Dan Kohuth had a comment on the rock removal. He complained several years ago about the rock removal across the street from him and there was nothing done. He also had a concern on the South Street project charges and asked how the town was going to recoup the money.

Tim Pender was in the audience with regard to the rock removal stated that this operation is not rock picking but strip mining.

David Hocking stated he will hound the soil conservation district every day about the rock removal.

Motion was made by Mr. Stracco, seconded by Mr. Desiderio to close the public portion of the meeting. All were in favor.

## **DEPARTMENT REPORTS:**

Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis to approve the department reports 1-8 on a consent agenda motion. All were in favor.

Zoning Officer-asked for the update on the rock removal discussion.

Recreation Committee-Mr. Desiderio advised that the Hay ride will be Saturday, October 26<sup>th</sup> and the fall ball softball girl's team came in 4<sup>th</sup> place.

Environmental Commission-they are moving forward with critical areas map with The Land Conservancy.

Farmland Preservation Committee-had a joint meeting with Open Space and talked about target areas.

Open Space-no report

Mayor David Boynton-advised there have been break ins in the area. He spoke with the police who advised that 2 men had been caught. The next issue is solar panels on roof tops; if there is a fire they could explode causing injury to the firemen and there should be a requirement that there be a turn off switch. Mr. Desiderio informed everyone that the panels are still generating electric. Lastly, he went over a meeting he had with the engineer Paul Sterbenz on the yellow house at the corner of Main Street and Route 612 spur and converting the property into a parking lot. The engineer thought it was a good idea and will work on some plans.

Deputy Mayor Christopher Kuhn-no report

Committeeman Christopher Stracco-advised that we are now on facebook and twitter.

Committeeman Alan DeCarolis-no report.

Committeeman Frank Desiderio reported that the overlay was done on Dutch Hill Road, Camp Wasigan Road and Greendell Road. He suggested speed limits on Pippen Hill Road, Camp Weahqua Road, Stage Road and Kerr Road. The engineer will work on this. A low bridge sign is needed on Mill Road so that trucks do not have to back up as they can't make it through the tunnel. The engineer will work on this.

Municipal Clerk-a request to use the meeting room on December 7th by Antler Ridge was approved.

## **EXECUTIVE SESSION:**

Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis to enter into Executive Session with regard to personnel matters. All were in favor. Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis to return to public session. All were in favor. Mr. Wacks announced that a discussion on a personal matter was resolved and an agreement will be entered into. Once the agreement is signed it will become public record.
