#2014-104 (Resolution to join the fund (Statewide)

WHEREAS, a number of local units have joined together to form the Statewide Insurance Fund ("FUND"), a joint insurance fund, as permitted by N.J.S.A.40A:10-36, et. seq.; and

WHEREAS, the statutes and regulations governing the creation and operation of joint insurance fund contain elaborate restrictions and safeguards concerning the safe and efficient administration of such funds; and

WHEREAS, the LOCAL UNIT has determined that membership in the FUND is in the best interest of the LOCAL UNIT.

WHEREAS, the LOCAL UNIT agrees to be a member of the FUND for a period of three (3) years, effective from January 1, 2015 terminating on January 1, 2018 at 12:01 a.m. standard time; and

WHEREAS, the LOCAL UNIT has never defaulted on claims, if self-insured, and has not been canceled for non-payment of insurance premiums for two (2) years prior to the date of this Resolution.

#2014-108 (Emergency Management Coordinator Services)

WHEREAS, the governing body of a municipality may enter into a contract with another local unit for the sharing of services within their jurisdictions of any service which either local unit is empowered to render within its own jurisdiction pursuant to N.J.S.A. 40A:65-1, et seq., known as the Uniform Shared Services and Consolidation Act: and

WHEREAS, the Township of Frelinghuysen has agreed with the Township of Green to enter into a Shared Services Agreement (the "Agreement"), pursuant to which the Township of Frelinghuysen shall appoint a Deputy Emergency Management Coordinator, and that Deputy Emergency Management Coordinator shall serve as the Emergency Management Coordinator for the Township of Green, on the terms and conditions set forth in the Agreement between the parties and pursuant to N.J.S.A. App. A: 9-40.1, et seq.; and

WHEREAS, by entering into the said Agreement, the Townships of Frelinghuysen and Green will conserve financial resources and enhance community relations.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Frelinghuysen, Warren County, New Jersey as follows:

- 1. The Mayor and Clerk of Frelinghuysen Township are hereby authorized to execute a Shared Services Agreement with Green Township for Emergency Management Coordinator Services, in a form acceptable to the Township Attorney.
- 2. A copy of the Agreement shall be open to public inspection at the Frelinghuysen Township Municipal Building immediately after passage of this resolution.
- 3. Pursuant to <u>N.J.S.A.</u> 40A:65-5, the Agreement shall take effect upon the adoption of this resolution and of a resolution by the Township of Green, and execution of the Agreement.
- 4. This resolution shall take effect according to law. Motion was made by Mr. Stracco, seconded by Mr. Kuhn to adopt said resolution. Roll call vote: Mr. Boynton-yes, Mr. Desiderio-yes, Mr. Kuhn-yes, Mr. Stracco-yes, Mr. DeCarolis-yes.

#2014-109 (Setting Executive Session)

WHEREAS, it is necessary to discuss items dealing with Contract negotiations in private or executive session; and

WHEREAS, under the Open Public Meetings Act (number 7 of the permitted exceptions to the requirements that a public body hold its meetings in public) it is permissible that such matters be discussed in executive or private session.

NOW, THEREFORE BE IT RESOLVED, on this 24th day of November, 2014 that the Township Committee of the Township of Frelinghuysen will adjourn to private or executive session to discuss the above mentioned and results or portions of that discussion will be made known in a reasonable length of time.

QUOTES:

The Clerk solicited three quotes for the township's insurance needs as follows: James A. Conners Agency, Morristown, NJ –did not quote Statewide Insurance Fund, Short Hills, NJ in the amount of \$32,180.00 Tri State Insurance (JIF), Augusta, NJ in the amount of \$32,096.80 At this time, the Committee went into executive session to discuss contract negotiations and upon returning motion was made by Mr. Kuhn, seconded by Mr. DeCarolis to approve the quote received from Statewide. Roll call vote: Mr. Stracco-yes, Mr. Kuhn-

yes, Mr. Boynton-no, Mr. DeCarolis-yes, Mr. Desiderio-yes.

OLD BUSINESS:

A response to purchase the small lot on 232 Spring Valley Road in the amount of \$400.00 was discussed. Since the letter to the purchaser did not include fees, motion was made by Mr. Kuhn, seconded by Mr. DeCarolis authorizing the attorney to get a description and prepare a deed. The expenses will need to be covered before we proceed. All in favor.

An Interlocal agreement for Emergency Management Coordinator services between Frelinghuysen Township and Green Township was approved on motion made by Mr. Stracco, seconded by Mr. Kuhn. All were in favor. Mr. Pachnos will remain EMC. Kenneth Lang will be the coordinator for Green Township. There will be two deputies-Mr. Izarry and Mr. Jurena. Mr. Pachnos is asking for \$2,200.00 for salary along with needing \$600.00 for radios. He would like us to join the Swift 9-1-1 with Green which will cost \$1,215.00 until August 2015.

Dawn Riley of Ackerson Road came before the Committee for help in getting high speed internet on her road. Martin Connor, who represented the town in the negotiations with Service Electric responded that Service Electric would only provide services if it was profitable. Scott Hendricks also of Ackerson Road advised that he also approached Service Electric and was unable to get any help. He contacted Century Link, who provides the telephone services in that area and they are working with him, however, he still needs a couple more signatures on his petition. It was decided that an e blast notice would be sent out of which the attorney needs to approve.

An interlocal service agreement between Frelinghuysen and Green for the construction department between Frelinghuysen and Green for a term of four consecutive years beginning January 1, 2015 and terminating on December 31, 2018 was approved on motion made by Mr. Kuhn, seconded by Mr. DeCarolis. All were in favor.

NEW BUSINESS:

The letter received from Green Township Volunteer Fire Department regarding the purchase of radios will be held for the next budget meeting.

A 2015 Municipal Alliance County contract reflecting both the award of funds and corresponding levels of service was approved to be signed by the Mayor and Clerk on motion made by Mr. Kuhn, seconded by Mr. Desiderio. All were in favor.

A letter of resignation received from Kevin Bailey from the Land Use Board was accepted with regret on motion made by Mr. Kuhn, seconded by Mr. Stracco. All were in favor. The Clerk was instructed to send a letter of thanks.

OPEN MEETING TO THE PUBLIC:

Motion was made by Mr. DeCarolis, seconded by Mr. Desiderio to open the meeting to the public. All were in favor. Spoke were:

Wendy Goetz who researched steward communities regarding sewer septic systems. Mr. Desiderio will go on the website she provided for additional information.

Martin Connor asked if anyone can walk on the Kids Camp after the town takes ownership of the property as it would be unsafe due to the fallen buildings and debris in the area.

Wendy Goetz asked what the timetable was on the salt shed. She was told it was on hold. She also asked if there were any changes to the outdoor furnace ordinance. She was informed that the LUB formed a subcommittee to look into this.

Motion was made by Mr. Stracco, seconded by Mr. Kuhn to close the public portion of the meeting. All were in favor.

DEPARTMENT REPORTS:

Motion was made by Mr. Stracco, seconded by Mr. Kuhn to approve the department reports 1-14 on a consent agenda motion. All were in favor.

Mayor David Boynton advised that the NJDOT approved the driveway opening permit on the Route 94 property. The town has to get releases from two residents on Meadow Oak Drive so that the Mosquito Commission can do the work on the basins. The Mayor received an email from Director of Finance at Alpha Borough asking if our CFO was interested in putting additional hours in Alpha. Mrs. Dyer is not interested at this time.

Committeeman Frank Desiderio-no report

Committeeman Alan DeCarolis-asked to hold the tax assessor's check until further clarification can be gotten on his charges for the computers in his office. He mentioned that Hope Township Environmental Committee will meet with our commission regarding Sustainable Jersey in the future.

Municipal Clerk-no report

Attorney Edward Wacks-a question was brought up about sick time, if the committee recalls there was an agreement reached with Mrs. Kleber and Mr. Crone but did not at that time change the agreement in accordance with the personnel policy. We do have a sick time policy with a cap of \$6,000. The Committee should rethink the policy and discuss it further at a work meeting as to whether they want to change it where they use it or lose it or continue with a cap. The Kids Camp closing will be held tomorrow, December 18th. The Committee will need to decide whether they are going to do any additional testing on the property since the environmental report came back positive. There is a greenhouse on the property as they were unable to remove it. It can be decided later what to do with it. Ed was able to receive a \$5,000 credit toward clean up of the property. Mr. Wacks asked the Committee to consider raising his retainer to \$1,750.00 as he is putting in more hours. Lastly, the Gerson easement is going forward.

EXECUTIVE SESSION:

Motion was made by Mr. Kuhn, seconded by Mr. DeCarolis to enter into executive session with regard to contract negotiations. All were in favor. Motion was made by Mr. Stracco, seconded by Mr. DeCarolis to return to public session. All were in favor. Upon returning the attorney stated that the Committee looked and compared both insurance proposals and because both coverage's and costs were about the same and almost identical the Committee decided to go forward.
