#2013-70 (Municipal Alliance)

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey.

WHEREAS, The Township Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and

WHEREAS, Frelinghuysen Township was approved for a Municipal Alliance grant for the January 1, 2013 through December 31, 2013 grant term; and

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse has extended the 2013 grant term until June 30, 2014, in order to transition the grant to a fiscal year rather than calendar year cycle; and

WHEREAS, funding has been made available to the Frelinghuysen Township Municipal Alliance in the amount of 50% of its approved 2013 grant total for the six month extension period of January 1, 2014 to June 30, 2014, contingent upon meeting the 25% Cash Match and 75% In-Kind Match grant requirements for the extension funding.

NOW, THEREFORE, BE IT RESOLVED, that the Frelinghuysen Township Committee does hereby authorize the submission of the grant extension for the Frelinghuysen Township Municipal Alliance grant in the amount of:

#2013-72 (Renew membership in Morris County JIF)

WHEREAS, the Morris County Municipal Joint Insurance Fund (hereinafter the Fund) is a duly chartered Municipal Insurance Fund as authorized by NJSA40A:10-36 et seq., and

WHEREAS, the Township of Frelinghuysen is currently a member of said Fund; and WHEREAS, effective December 31, 2013, said membership will expire unless earlier renewed, and;

WHEREAS, the Mayor and Committee of the Township of Frelinghuysen has resolved to renew said membership;

NOW, THEREFORE it is agreed as follows:

- 1. Frelinghuysen Township hereby renews its membership in the Morris County Municipal Joint Insurance Fund for a three (3) year period, beginning January 1, 2014 and ending January 1, 2016 at 12:01 a.m.
- 2. The Township of Frelinghuysen hereby ratifies and reaffirms the Indemnity and Trust Agreement, Bylaws and other organizational and operational documents of the Morris County Municipal Joint Insurance Fund as from time to time amended and altered by the Department of Banking and Insurance in accordance with the Applicable Statutes and administrative regulations as if each and every one of said documents were re-executed contemporaneously herewith.
- 3. The Township of Frelinghuysen agrees to be a participating member of the Fund for the period herein provided for and to comply with all of the rules and regulations and obligations associated with said membership.
- 4. In consideration of the continuing membership of the Township of Frelinghuysen in the Morris County Municipal Joint Insurance Fund agrees, subject to the continuing approval of the Commissioner of Insurance to accept the renewal application.
- 5. Executed the 18th day of December, 2013 as the lawful and binding act and deed of the Township of Frelinghuysen, which execution has been duly authorized by public vote of the governing body.

#2013-74 (Setting executive session)

WHEREAS, it is necessary to discuss items dealing with personnel in private or executive session; and

WHEREAS, under the Open Public Meetings Act (number 4) of the permitted exceptions to the requirements that a public body hold its meetings in public it is permissible that such matters be discussed in executive or private session.

OLD BUSINESS:

Due to the lack of people wanting to serve on the Municipal Alliance Committee, motion was made by Mr. Kuhn, seconded by Mr. Desiderio to turn the Municipal Alliance over to shared services with Hope and White townships. All were in favor. This will take effect June 30, 2014.

NEW BUSINESS:

Engineer Paul Sterbenz gave the Committee an annual update brief on Stormwater management. He stated that all work that had been assigned to him on South Street has been completed and lastly he doesn't know at this time if Frelinghuysen is going to receive any DOT monies for Kerrs Corner Road. Lastly, it advised that North Warren Estates had made a commitment to finish the improvements on Lackawanna Drive which was too had been done by the fall of 2013. Most of the improvements have been done at this time. The only improvement that has not been done is the planting of the street trees. Since its now winter, Mr. Benbrook would like to hold off on the planting. The Committee decided that they would like the trees planted now, especially we are having a warm spell. A deed is being sent to Mr. Wacks and an as built survey plan will need to be submitted along with a 2 year maintenance bond.

John Cowell, President of the Sussex/Warren Soccer Club and Oscar Castillo presented Mr. Desiderio with a \$271.10 check from United Soccer Academy for use of the recreation field.

OPEN MEETING TO THE PUBLIC:

Motion was made by Mr. DeCarolis, seconded by Mr. Desiderio to open the meeting to the public. All were in favor.

Mr. Connor asked if Mr. Glynn's expenses were divided between his other towns. He was advised that Mr. Glynn only does fire inspections for Frelinghuysen.

Mrs. Muller asked if the snow plows could turn away from the driveways and not plow snow in them. Mr. Desiderio will take care of this.

Motion was by Mr. DeCarolis, seconded by Mr. Desiderio to close the meeting to the public. All were in favor.

DEPARTMENT REPORTS:

Motion was made by Mr. Desiderio, seconded by Mr. DeCarolis to approve the department reports 1-9 on a consent agenda motion. All were in favor.

Recreation Committee-Mr. Desiderio reported that basketball is going good and that the baseball field has been done but another load of clay is needed.

Environmental Commission-no report

Open Space Committee-no report

Mayor David Boynton-Mr. Boynton reported that he received a call from the Assistant of New Jersey State Parks and will meet with him and Mr. Desiderio tomorrow regarding the overlay of the road thru the park. Mayor Boynton wished everyone a Merry Christmas and Happy New Year. Deputy Mayor Christopher Kuhn-Mr. Kuhn related that he was happy with the accomplishments of the Committee this year. He went over the paper work on the leasing of a new truck and likes the leasing agreement and thought that we should decide soon.

Committeeman Alan DeCarolis-Mr. DeCarolis wished everyone a Merry Christmas and Happy New Year.

Committeeman Frank Desiderio-Mr. Desiderio thought that we should look into getting a larger salt shed. There was an issue with people not shoveling the sidewalks in front of their homes along with people shoveling the snow into the roadway. Mr. Desiderio recommended that the Clerk send a letter to the homeowners along Main Street, Lackawanna Drive and Saddle Ridge reminding them that they need to clear the snow from the sidewalk and to put a reminder on the website that they can't shovel snow into the roadway. The Clerk was instructed to send the letters on motion made by Mr. Desiderio, seconded by Mr. Kuhn. All were in favor.

Committeeman Christopher Stracco-Mr. Stracco told the Committee that it was a pleasure to work with them this year and was happy with the accomplishments. He is working on the town owned tax liens and will have a report next year.

Attorney Edward Wacks-Mr. Wacks related that there was no litigation and will try to keep it that way. He announced that David Brady is now an associate in his law firm and lastly there will be no increase in his charges for 2014.
