PROCLAMATION IN HONOR OF HELEN (PRYSLAK) NATYZAK WHEREAS, Helen Pryslak was born on April 16, 1920, to Ukrainian immigrants who moved to Great Meadows. #2020-06 ORDINANCE ESTABLISHING ALTERNATE CLAIM PAYMENT PROCEDURES DURING TIMES OF PUBLIC EMERGENCY WHEREAS, N.J.S.A. 40A:5-17 establishes procedures local units must follow for payment of claims, and requires governing bodies to

approve all claims prior to payment, unless the local unit adopts other procedures that permit payment without governing body approval; and WHEREAS, a municipality may establish such other procedures by ordinance, provided that the requirements of the said statute are met; and WHEREAS, the public state of emergency presented by COVID-19 has shown that it is necessary and appropriate to establish such procedures so that in the event of a state of emergency, the Township of Frelinghuysen can meet its obligations, while assuring proper review of the Township's bills. NOW, THEREFORE, BE IT ORDAINED by the Township of Frelinghuysen, County of Warren, State of New Jersey that the Code of the Township is hereby amended by adding thereto a new Section 2-9, to read as follows:

Section I The Frelinghuysen Township Code is amended by adding thereto a new Section 2-9, to read as follows:

2-9 Payment 0f Claims During State of Emergency Pursuant to N.J.S.A. 40A:5-17, the following procedure may be followed for the payment of claims during the term of a state of local disaster emergency proclaimed by the Township Emergency Management Coordinator: a. Each claim, payment of which is due before the next scheduled meeting of the Township Committee, shall be reviewed, and if appropriate approved for payment by the members of the Finance Committee, who shall be designated as the certifying and approval officers pursuant to N.J.S.A. 40A:5-17. No claim shall be approved unless it is accompanied by the appropriate voucher signed by the vendor, together with any other necessary supporting documentation. b. The Finance Committee, in approving same, shall certify to the Township Committee that the work that is the subject of the voucher has been performed or the product has been approved by the Township, and that based on information from the Chief Financial Officer, there are sufficient funds for payment as well as legal authorization to pay same. c. As long as the procedure set forth in this Section is compliant, the Township Committee shall ratify the payment of any approved claims at its next meeting. Section II 1. All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency. 2. If any word, phrase, clause, section or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect. 3. This ordinance shall take effect immediately upon final passage and publication as required by law.

#2020-07 AN ORDINANCE AMENDING THE LAND DEVELOPMENT CHAPTER OF THE CODE OF THE TOWNSHIP OF FRELINGHUYSEN TO ADOPT A NEW ZONING MAP

WHEREAS, the Frelinghuysen Township Mayor and Committee adopted Ordinances in 2013 and 2016 to eliminate the Professional Office Zone and replace it with the Neighborhood Commercial Zone, additionally, the Neighborhood Commercial Zone was expanded along Route 94, however, the Zoning Map was never amended to reflect said changes; and WHEREAS, the Mayor and Committee wish to revise the Township Zoning Map to reflect the 2013 and 2016 zone changes. NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey as follows: Section I Amend the Land Development Ordinance to replace Attachment 11 entitled "Zoning Map" with the attached Zoning Map. Section II Amend the Land Development Ordinance, Section 303 entitled "Zoning Map and Critical Areas Map" as follows with new text underlined and text for deletion in strikeout: § LDO-303 ZONING MAP AND CRITICAL AREAS MAP. The boundaries of said zoning districts are hereby established as shown on the Zoning Map, Township of Frelinghuysen, dated November 19, 2003 and revised through December 19, 2005 April 2020, and revised by Ordinance No. 2013-09, adopted June 19, 2013, which, with all explanatory matter thereon, is hereby adopted and made a part of the

Ordinance. An official copy of said Map, indicating the latest amendments, shall be kept up-to-date in the office of the Construction Official for the use and benefit of the public and shall have the most current revision date shown thereon. The Zoning Map shall be the official reference as to the current zoning classification of land within the boundaries of the Township of Frelinghuysen. Section III Amend the Land Development Ordinance, Section 305 entitled "Zoning Map Amendments" as follows with new text underlined and text for deletion in strikeout: § LDO-305 ZONING MAP AMENDMENTS. The Township of Frelinghuysen Zoning Map, dated April 2020, incorporates all amendments to date. The Zoning Map can be found under Attachment 11. is amended as follows: A. Pursuant to Ordinance No. 2013-09, adopted June 19, 2013: 1. The "PO" Professional Office Zone is hereby eliminated. 2. All lands formerly in the "PO" Professional Office Zone shall now be included in the "NC" Neighborhood Commercial Zone. B. Pursuant to Resolution No. 2016-135 adopted December 21, 2016, the NC Commercial Zone along Route 94 is expanded to encompass both sides of Route 94 from the Fredon Township border to Kerr Road, as shown in the 2016 Master Plan Reexamination, p. 30.—Section IV

- 1. All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.
- 2. If any word, phrase, clause, section or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.
- 3. This ordinance shall take effect immediately upon final passage and publication as required by law.

#2020-34 WHEREAS, it is anticipated that Frelinghuysen Township will not be able to issue tax bills for the third quarter 2020 payment on a timely basis due to the COVID-19 crisis and adjustments to the State Budget calendar, and; WHEREAS, the State of New Jersey, Division of Local Government Services has recommended that all municipalities considering sending their residents estimated third quarter tax bills due to these changes, and; WHEREAS, Frelinghuysen Township has determined that there could be insufficient cash flow to support operations if the third quarter tax collections are not received in a timely manner; NOW, THEREFORE BE IT RESOLVED, by the Mayor and Committee of Frelinghuysen Township, Warren County, that:

- 1. The Tax Collector be and is hereby directed to take all steps necessary to send out estimated tax bills for the third quarter 2020.

#2020-35 TOWNSHIP OF FRELINGHUYSEN, COUNTY OF WARREN, STATE OF NEW JERSEY RESOLUTION REQUESTING THE STATE AND FEDERAL GOVERNMENTS TO IMMEDIATELY ALLOCATE CRITICALLY NEEDED EMERGENCY AND ECONOMIC FUNDING TO THE COUNTY OF WARREN FOR THE COVID-19 PANDEMIC WHEREAS, in response to the deadly COVID-19 ("Corona Virus") pandemic the Federal Government recently enacted several pieces of legislation aimed at reducing the economic impact and protecting public health; and WHEREAS, the Corona virus Aid, Relief and Economic Security Act (the "CARES Act") is the largest emergency aid package in United States History and provides for over two trillion dollars (\$2,000,000,000,000) in emergency and economic aid and allocates billions of dollars of relief to individuals, businesses, the health care system and state, county and local governments; and WHEREAS, on April 2, 2020, the United States Senators for the State of New Jersey, Robert Menendez and Corey Booker, announced the

release of the first wave of Federal funding pursuant to the CARES Act under which New Jersey would receive a combined total in excess of eighty-two million dollars (\$82,000,000) in State and local funding and of which fifteen million seven-hundred thousand dollars (\$15,700,000) in discretionary funding was allocated directly to the State Government; and WHEREAS, notwithstanding that Northern New Jersey has one of the highest concentrations of confirmed cases in the entire world and is currently considered to be at the epicenter of the national and global emergency caused by the deadly Corona Virus, the County of Warren is only one (1) of four (4) New Jersey Counties to not receive any Federal funding; and WHEREAS, while several other counties within the State with significantly less Corona Virus cases received Federal aid; the taxpayers and residents of Warren County and a few other counties have been marginalized, ignored and left to carry the heavy burden and cost of responding to the most significant national emergency that has faced this Country since World War 2 alone and without the benefit of critically needed Federal and State assistance; and WHEREAS, unlike in other parts of the State where testing centers have been opened with the help of State or Federal assistance. Warren County, with the assistance of St. Luke's Hospital and local municipalities, took action to open a testing center on its own initiative and funded solely by the County; NOW, THEREFORE, BE IT RESOLVED by the Township of Frelinghuysen Township Committee, County of Warren, State of New Jersey, imploring Federal and State Government to take notice of the significant impact on residents and taxpayer of Warren County caused by the Corona Virus epidemic and to take immediate action to correct and address the inequities caused by the current allocation of State and Federal and provide the necessary funding and resources to the County of Warren and municipalities within the County to protect the health and safety of the public. BE IT FURTHER RESOLVED that a certified copy of this resolution be sent to Governor Phil Murphy, Senator Robert Menedez, Senator Corey Booker and the Warren County Board of Chosen Freeholders. **CERTIFICATION** I. #2020-36 TOWNSHIP OF FRELINGHUYSEN, COUNTY OF WARREN, STATE OF NEW JERSEY RESOLUTION IMPLORING THE GOVERNORS OF NEW JERSEY AND PENNSYLVANIA, AS WELL AS THE BOARD OF TRUSTEES OF THE LEHIGH VALLEY HEALTH NETWORK, TO PROMULATE UPDATED PROTOCOLS REGARDING OBSTETRICAL LABOR, DELIVERY AND VISITATION WHEREAS, to witness the birth of a child is our best opportunity "to experience the meaning of the word miracle" (Paul Carvel); and **WHEREAS**, one of the greatest joys experienced by a spouse is being able to participate in the birth of and have that initial bonding with a new baby; and WHEREAS, many Warren County couples have brought it to the attention of the Township of Frelinghuysen Township Committee that Lehigh Valley Health Network has imposed a ban on New Jersey visitors, including for maternity visits; and WHEREAS, this ban is particularly discriminatory again Warren County couples, as neither hospital in Warren County offers maternity services, leaving expectant parents no choice but to use medical facilities located outside of the County; and WHEREAS. Warren County's number of VOCID-19 infections is far fewer than the amount reported in Pennsylvania's Lehigh Valley, where Lehigh Valley Health Network maternity facilities are located, so a ban on family members assisting in the birth of a baby is an unnecessary and heavy-handed approach not supported by the facts; and WHEREAS, the New York Department of Health has updated specific guidelines for obstetrical and pediatric settings providing for familial support in labor and delivery as well as the immediate postpartum period if the patient so desires; and WHEREAS, New Jersey Health Commissioner Judith Persichilli has issued an order to hospitals requiring them to allow one designated support person to be with the expectant mother, deeming such support as essential to patient care throughout labor, delivery, and the immediate postpartum period; and WHEREAS, the Township of Frelinghuysen Township Committee shares the sentiment that a child's birth is a special moment and should be celebrated; and WHEREAS, the delivery of a baby without a spouse or any family members present creates additional stress and anxiety, which could impact delivery; and WHEREAS, an amended order on visitation, being cognizant of

symptoms of COVID-19 and protocols addressing the health, safety and welfare of all patients and staff, should be implemented to ensure a practical, prudent, and reasonable policy; **NOW**, **THEREFORE**, **BE IT RESOLVED** by the Township of Frelinghuysen Township Committee, County of Warren, State of New Jersey, requests that Governor Phil Murphy of the State of New Jersey and Governor Tom Wolfe of the Commonwealth of Pennsylvania, as well as the board of trustees of the Lehigh Valley Health Network, modify the policies for labor and delivery for the birth of a child to permit participation by designated family; and **BE IT FURTHER RESOLVED** that a certified copy of this resolution be sent to Governor Phil Murphy, Governor Tom Wolf, and to the board of trustees of the Lehigh Valley Health Network and the Warren County Board of Chosen Freeholders. **CERTIFICATION** I, Donna Zilberfarb, Municipal Clerk of the Township of Frelinghuysen, do hereby certify the above to be a true copy of a resolution adopted by the Frelinghuysen Township Committee at their meeting of April 22, 2020 Donna M.
