# **ORDINANCES:**

#2020-10 ORDINANCE TO AMEND SECTION 9-3 OF THE FRELINGHUYSEN TOWNSHIP CODE, ENTITLED "BAMBOO" WHEREAS, bamboo is an invasive species which has become a nuisance to the residents of Frelinghuysen Township; and

WHEREAS, the Mayor and Committee of the Township of Frelinghuysen previously adopted Section 9-3 of the Frelinghuysen Township Code, in order to address complaints regarding the unwanted spread of bamboo in areas where it encroaches on the public right-of-way; and WHEREAS, the Township has received additional complaints about bamboo in areas other than where it encroaches on the public right-of-way, and as believe it is necessary and appropriate to amend Section 9-3 of the Township Code. NOW, THEREFORE, BE IT ORDAINED by the Township of Frelinghuysen, County of Warren, State of New Jersey as follows: Section 1 Section 9-3 of the Frelinghuysen Township Code is hereby amended as follows (additions are underlined, deletions are stricken through): 9-3 BAMBOO

- A. No persons, residents, citizens, property owners and/or tenants of the Township shall plant or cultivate bamboo after the effective date of this Section.
- **<u>B.</u>** No persons, residents, citizens, property owners and/or tenants of the Township shall <del>plant, cultivate, or</del> cause to grow, any bamboo on any lot and/or parcel of ground anywhere within the geographic boundaries of the Township of Frelinghuysen in such a manner as to cause <u>the bamboo to spread beyond the boundaries of their property.</u> any portion of the plant or roots to encroach on the public right-of-way.
- <u>C</u>. Complaint and notice, order for removal and compliance. Whenever a complaint is received by the Township regarding the <u>planting or cultivation</u>, or encroachment of any bamboo plant or root <u>beyond the boundaries of a property</u>, into the <u>public right-of-way</u>, or whenever the Township, on its own observations and inspections witnesses same, the Township shall cause notice to be served and the following actions to occur:
  - (1) The notice shall be mailed by certified mail, return receipt requested, properly addressed and with sufficient postage, and also by first-class mail. Notice by certified mail shall be deemed complete on the date of personal delivery, or the date the certified mail is marked refused or unclaimed or otherwise undeliverable by the United States Post Office. First-class mail shall be deemed delivered within five calendar days of its being mailed by the Township.
  - (2) The notice shall specify the nature of the violation(s).
  - (3) The notice shall state that the violation(s) must be corrected within 30 calendar days from the date of the received or returned mailing.
  - (4) The notice shall state specifically what must be done by the responsible party to correct the violation(s).
- <u>D</u>. Investigations; reports. The Director of Public Works, Road Supervisor, Construction Official or the Health Officer of the Township shall be considered the proper officers to investigate all lands within the limits of the Township to determine violations of this section, and to issue notices pertaining to same.
- $\underline{\mathbf{E}}$ . Violations and penalties; remediation and collection of remediation costs.
  - (1) Any person who shall violate any of the provisions of this section shall be liable, upon conviction, to the penalty stated in Chapter I, Section 1-5.
  - (2) In addition to and not in lieu of any penalties that may be assessed, If the violation is not remedied within the time set forth in the notice sent pursuant to Section 9-3C2B hereof, the Township is hereby authorized to remove or have removed any bamboo encroaching beyond the boundaries of a property, on the public right-of-way, and to take all reasonable steps to eradicate the regrowth of the bamboo beyond the boundaries of the property, into the public right-of-way, and to restore the land to the condition in which it existed prior to such removal and eradication, all at the cost and expense of the property owner from whose property the bamboo emanated. Upon such removal, the following procedure shall apply regarding the payment and collection of the amounts expended by the Township of Frelinghuysen.
  - (3) The officer or employee of the Township in charge of the removal of bamboo shall certify the cost thereof to the Mayor and Committee. The Mayor and Committee shall examine such certificate and, if found to be correct, shall cause such cost to be charged against such lands after affording the owner of the property a reasonable opportunity to appear before the Mayor and Committee or its designated agent.
  - (4) The amounts charged shall immediately become due and payable to the Township. If the owner of the property fails to pay such amounts, the same shall become a lien on the property of such owner and shall bear interest in the same manner as is charged on unpaid taxes. Such unpaid amounts shall be deemed, for the purpose of collection thereof, a tax upon such real estate to be added to and become a part of the taxes next to be levied and assessed against that real estate. Such tax shall be enforced and collected with interest by the same officer and in the same manner as all other municipal taxes.
- <u>F</u>E. In the event that the Township of Frelinghuysen shall cause bamboo to be removed, the owner of the property from which the bamboo emanated shall indemnify and hold harmless the Township of Frelinghuysen and its officers and employees from and against all liability, including loss, damage, costs, attorneys' fees, causes of action, claims and/or judgments arising from said bamboo removal and restoration of the property. For

the sole purpose of this section and for no other purpose, the owner or developer shall be deemed to have appointed the Township of Frelinghuysen as the owner's or developer's agent should the Township cause bamboo to be removed from such owner's or developer's property. **Section II** 

- 1. All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.
- 2. If any word, phrase, clause, section or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.
- This ordinance shall take effect immediately upon final passage and publication as required by law. **NOTICE** Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading at the regular meeting of the Frelinghuysen Township Committee held on July 15, 2020 and will be considered for final reading and adoption at the meeting of the Frelinghuysen Township Committee to be held on August 19, 2020 at the Municipal Building, 210 Main Street, Johnsonburg, New Jersey at which time and place all interested parties may appear for or against the passage of said Ordinance. #2020-62 WHEREAS, the Township of Frelinghuysen plans to improve Greendell Road between Dark Moon Road (CR 519) and a point 3,500 linear feet to the northeast; and WHEREAS, the Township has obtained a grant from the municipal aid portion of the Transportation Trust Fund to help fund the project; and WHEREAS, the Township has appropriated the funds and plans on constructing the improvements in September 2020; and

#### **COMMITTEE REPORTS:**

- Mayor Chris Stracco stated that the municipal courts and Green Township Fire truck will be discussed in executive session. He had nothing further to discuss.
- Deputy Mayor Ramos discussed the zoom meeting that Congressman Gottheimer held for internet in the area. He did not attend but watched the meeting and explained that it was everything that has been discussed previously with the surrounding towns. He has been in contact with Mr. Boyle from Planet Networks and explained the set up for homeowners with that company. Mr. Ramos continues to have close contact with Altice.
- · Committeeman David Boynton had nothing to report
- Committeeman Frank Desiderio had nothing to report
- Committeeman Todd McPeek had nothing to report
- Attorney Rich Beilin discussed the parcel on Greendell Road that a letter needs to be written for and he will take care of that letter and get it back to the relator. This was discussed a few months ago.
- Municipal Clerk Donna Zilberfarb discussed an additional check that needed to be added to the bills list for Jefferson Softball League for the fall ball season. She also discussed the League of Municipalities being cancelled and asked the committee if the November dates could be changed back to normal meeting dates. Work session would be switched to November 12 (due to Veteran's Day on the 11<sup>th</sup>) and regular meeting date to November 18. The committee was in agreeance. Ms. Zilberfarb will advertise those dates for November. She also let the committee know that the township insurance is up for renewal and has submitted paperwork to SBOne Insurance for the renewal process. An RFP will be sent out and will work with Danette Dyer to get that taken care of.

# **OLD BUSINESS:**

- Salt shed Mr. Stracco explained that the plans have been submitted to SHIPO for approval and were received on July 27, 2020. They have 30 days to respond.
- Employee handbook Hold to September work session on 9/9/2020.

# **NEW BUSINESS:**

- Sadie Forbes was present during the meeting and asked the Mayor and Committee for approval
  of the locations for 2 signs. Mr. Stracco asked for authorization to sign the letter Ms. Forbes
  needs and to approve the locations. Motion was made by Mr. Desiderio to approve the Mayor
  to sign letter and to approve the locations requested, seconded by Mr. Ramos. All were in
  favor. Ms. Zilberfarb will get the signed letter to Ms. Forbes.
- The resignation of Donna Eitner, Land Use Board was accepted with regrets on a motion by Mr. Desiderio, seconded by Mr. Boynton. All were in favor. Ms. Zilberfarb will send a letter with regrets to Ms. Eitner.
- Mr. Ramos discussed parking on Hess road and blocking the road causing a safety issue. Mr. Desiderio stated that it is an ongoing issue with that road and mentioned that no parking signs were supposed to be put up for winter season. Mr. Ramos recommended putting signs up and stating on them that cars will be towed. Questions of enforcement were brought up. Mr. Beilin will get information to Mr. Ramos on tow zones and no parking signs. He will also get information on towing and who can enforce it (ie. Can a resident or does it need to be township or state police).

### **DEPARTMENT REPORTS:**

Motion was made by Mr. Desiderio for a consent agenda for department reports 1-10, seconded by Mr. Ramos. All were in favor.

DPW – Ms. Zilberfarb let the committee know that the ad for the laborer position will be advertised Friday, Saturday and Monday in the NJ Herald and all resumes are due by September 15, 2020. Looking at October meeting for hire. She also discussed tar and chip of State Park Road, South Town Road, and Camp Weaqua road. She recommended that if not completed within the next couple of weeks to ask Morris Asphalt to be put on the top of list for 2021 unless they will guarantee the work if

done late. Mr. Boynton, Mr. McPeek and Mr. Desiderio all agreed not to go too late in the season. Ms. Zilberfarb also let the committee know that the last storm a tree came down on Stage Coach road and Natures conservancy had contacted the dpw to see when it would be removed. It was a large tree that was past the Natyzaks residence. It wouldn't be our responsibility but if we had to remove we'd need to pay to have it removed. Natures conservancy will be removing the tree.

Mr. McPeek asked about mowing of the fields and placing an ad for part time help. Ms. Zilberfarb explained that although that would be great, the process would have us in the middle of September to hire and she felt that the weeks the dpw couldn't get to it that possibly someone could volunteer to help and mow when necessary. Mr. Ramos stated that Justin Stanley has mowed a couple of times. Ms. Zilberfarb also asked that since the rec center is closed that the be mowed every other week for now unless there was something going on. Currently, there is something for October. Ms. Zilberfarb will make sure the grounds are cut and weed wacked for that event.

Land Manager – mentioned that if anyone had any questions regarding their report to please let him know.

Recreation committee – Mr. Ramos discussed the fire pit and regulations and will be meeting with Ms. Zilberfarb to get information on fire code. He told the committee that Saturday they worked on the fields and spread the clay out. He also discussed that they agreed that the rec center will remain closed to all classes but could be open for one day events. Mr. McPeek added that they may be hosting fall ball softball finals this year.

Environmental Commission - no meeting.

Farmland/Open space Committee – Mr. Stracco updated the committee on his conversation with Sandy Urgo regarding any farmland preservation. There are a few farms and she will get back to Mr. Stracco by months end.

Historic Committee - no meeting.

#### **OPEN MEETING TO THE PUBLIC:**

Motion was made by Mr. Boynton, seconded by Mr. Ramos to open meeting to the public limited to 20 minutes with 3 minutes per member of the public. All were in favor. Spoke were:

- Mr. Kohuth asked about the documents that were submitted to SHIPO for the salt shed. Mr. Stracco said to complete an OPRA request and Ms. Zilberfarb will get those for him.
- Mr. Kohuth also asked about the green township fire truck and why it was being discussed in
  executive session and not in public session. Mr. Stracco explained it was because it was for
  contract negotiations and Mr. Beilin confirmed that is one of the 9 subject matters that may be
  covered in executive session.
- Mr. Kohuth inquired about the road crew being a man down and asked what that meant. Mr. Beilin stated that an employee in dpw was terminated.

- Mr. Connor asked Ms. Zilberfarb if she received the check for the open space grant and she
  confirmed receipt of the check. He also asked about the event that had happened a few weeks
  ago in regards to the tent that was erected over the septic field and asked if that was ok to do
  that. Mr. Desiderio stated yes it was ok to put the tent over the septic field.
- Mr. Kohuth inquired about the booster club and whatever happened to it. Mr. Desiderio stated that no funds ever came from the township and that the booster club is still in affect and so are the funds.

Motion was made by Mr. Desiderio, seconded by Mr. Boynton to close to the public. All were in favor.
