- 2. Monthly department reports are required from the Tax Collector, Tax Assessor, Chief Finance Officer, Building Inspector, Zoning Officer, Warren County Health Department, Planning Board and Animal Licensing Official to be given to the Clerk one week prior to the Township Committee meeting.
- 3. Interest on current and delinquent taxes shall be 8% on the first \$1,500.00 of the delinquency and 18% per annum on any amount in excess of \$1,500.00 and 6% in excess of \$10,000.00 for who fails to pay delinquent taxes prior to the end of the calendar year.
- 4. The Tax Collector, Township Clerk, Building Inspector, Zoning Officer, Animal Licensing Official shall turn over monies collected and in hand at the end of the month to the Clerk to be recorded in the minutes.
- 5. The North Warren branch of the Lakeland Bank be depository for monies collected by the Tax Collector, Chief Finance Officer, Zoning Officer, Animal Licensing Official, Building Inspector, Small Cities, and Township Clerk.
- 6. The Bank of America be depository for monies collected by the Chief Finance Officer for escrow accounts.
- 7. The Star Gazette and New Jersey Herald be official newspapers for the publication of all legal items.
- 8. The Tax Collector be authorized to issue tax search requests.
- 9. The Township Clerk be authorized to issue certificates as to liability for assessments for municipal purposes or improvements.
- 10. The Tax Assessor be authorized to issue certified list of property owners.

WHEREAS, the Mayor and Township Committee of the Township of Frelinghuysen require the services of a Municipal Attorney, Municipal Engineer, Bond Counsel and Auditors; and WHEREAS, funds will be available in the 2007 budget to pay for the aforesaid services:

#2007-05:

WHEREAS, the Township of Frelinghuysen has a need to acquire a municipal Auditor as a non-fair and open contract pursuant to provisions of N.J.S.A.19:44A-20.5; and

WHEREAS, the Chief Finance Officer has determined and certified in writing that the value of the acquisition will exceed \$17,500.00; and

WHEREAS, the anticipated term of this contract is one year; and

WHEREAS, Ardito & Co., LLP has submitted a proposal dated December 5, 2006, indicating they will provide the auditor services for the anticipated fee of \$17,650.00; and

WHEREAS, Ardito & Co., LLP has completed and submitted a Business Entity Disclosure Certification which certified that Ardito & Co., LLP has not made any reportable contributions to a political or candidate committee in the Township of Frelinghuysen in the previous one year, and that the contract will prohibit Ardito & Co., LLP from making any reportable contributions through the term of the contract; and

WHEREAS, the required certificate for the availability of funds has been filed by the chief finance officer providing that legally appropriated balances are available to cover the amount of the contract as required by N.J.A.C.5:30-14.5 and that fees for the aforementioned auditing and non-auditing services shall be made available by appropriate inclusion in either an annual municipal budget which includes current, revenue sharing and utility provisions, by budget amendments for Federal program spending or by inclusion in an appropriate bond ordinance

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Frelinghuysen, authorizes the Mayor and Clerk of the Township of Frelinghuysen to enter into a contract with Ardito and Co., LLP as described herein as auditors on and in behalf of the Township of Frelinghuysen for the year 2007; and

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification and Determination of Value be placed on file with this resolution; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in a legally designated publication.

Motion was made by Boynton, seconded by Natyzak-Osadca to approve said resolution. Roll call vote: Natyzak-Osadca-yes, Boynton-yes, Charles-yes.

NEW BUSINESS:

The Professional services agreement with Maser Consulting for professional services for 2007 was approved on motion made by Boynton, seconded by Natyzak-Osadca. All in favor. There were several minor changes incorporated in the new agreement whereby the hourly rate was increased to \$130.00 per hour for Paul Sterbenz. The rate for Paul Niehoff will be at \$120.00 per hour. A retainer in the amount of \$750.00 was discussed.

The Morris Land Conservancy agreement will be on hold until a further date.

The Municipal Clerk asked the Committee if there would be a conflict if she joins the campaign for Warren County Acting Clerk Pat Kolb. Ms. Kolb is being considered to replace Clerk Terry Lee who retired in December 2006. After conferring with the attorney's, the Committee decided that there would be no conflict.


The Committee inquired as to whether the grant money allocated for the South Street flooding could be accepted ahead of time. The attorney will look into this.
