#### #2011-02 (Committee resolution)

BE IT RESOLVED, by the Township Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey that the following resolution be adopted:

That all Township officials be present at each meeting on a quarterly basis

Monthly department reports are required from the Tax Assessor, Tax Collector, Chief Finance Officer, Building Department, Zoning Officer, Warren County Health Department, Knowlton Court and Animal Licensing Official to be given to the Clerk one week prior to the Township Committee meeting.

The Township Clerk, Building Department, Zoning Officer, and the Animal Licensing Official shall turn over monies collected and in hand on a weekly basis to the Township Clerk to be deposited.

Interest on current and delinquent taxes shall be 8% on the first \$1,500.00 of the delinquency and 18% per annum on any amount in excess of \$1,500.00 and 6% in excess of \$10,000.00 for who fails to pay delinquent taxes prior to the end of the calendar year.

The North Warren branch of the Lakeland Bank is depository for monies collected by the Tax Collector, Chief Finance Officer, Zoning Officer, Animal Licensing Official, Building Department, COAH, Small Cities and Township Clerk.

The Bank of America is the depository for monies collected by the Chief Finance Officer for escrow account.

The New Jersey Herald and Express-Times are the official newspapers for the publication of all legal items.

The Tax Collector is authorized to issue tax search requests.

The Tax Assessor is authorized to issue certified list of property owners.

The Township Clerk is authorized to issue certificates as to liability for assessments for municipal purposes or improvements.

# #2011-03 (Budget resolution)

WHEREAS, N.J.S.A.40A:4-19 provides that where any contract commitment or payments are to be made prior to the final adoption of the 2011 budget, temporary appropriations should be made for the purpose and amounts required in the manner and time herein provided; and

WHEREAS, the date of this resolution is within the first thirty (30) days of January 2011; and

WHEREAS, one-fourth of the total appropriations in the 2010 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvements fund and public assistance in said 2011 budget in the sum of \$230,000.

NOW, THEREFORE BE IT RESOLVED, by the Frelinghuysen Township Committee that the following appropriations be made and that a certified copy of this resolution be transmitted to the Chief Finance Officer for her records.

### #2011-04 (Professional Services)

WHEREAS, there exists a need for various Township Professionals;

WHEREAS, the Local Public Contracts law (N.J.S.A.40A:11-1 et. seq.) requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be publicly advertised.

WHEREAS, the following award is for a contract that is not in excess of \$26,000 as certified by the Chief Finance Officer of the Township of Frelinghuysen, and pursuant to N.J.S.A.19:44A-20.4, may be awarded by the Township Committee.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey as follows:

# #2011-05 (Open Space Tax)

WHEREAS, section 2-39.3 of the Ordinances of the Township of Frelinghuysen requires that the Open Space tax for the year 2011 be set at or before the meeting when the budget is adopted; and

WHEREAS, the Township Committee desires to establish a \$0.02 cent open space tax per \$100.00 of assessed valuation.

NOW, THEREFORE BE IT RESOLVED, that it is hereby, established an open space tax of \$0.02 cents per \$100.00 assessed valuation pursuant to Ordinance 2-39.3.

### #2011-07 (Appoint Public Works director)

WHEREAS, the Department of Public Works shall have charge of and supervision over the care, maintenance and construction of all streets, alleys and public ways; the construction, operation and maintenance of all storm-water and sanitary sewers, and all street gutters and drains and the appurtenances thereto; and

WHEREAS, the Department of Works shall consist of the Director Public Works shall be under the immediate control and direction of the Township Committeeman in charge of public works, who shall be designated "Director of Public Works" and who shall be subject and subordinate to the ultimate control and direction of the Township Committee.

NOW, THEREFORE BE IT RESOLVED, that Thomas Charles shall be appointed as "Director of Public Works for the year 2011."

A letter of resignation from William Bromski resigning from the Environmental Commission was accepted with regret on motion made by Durling, seconded by Boynton. All in favor. The Clerk was instructed to send a letter of thanks to Mr. Bromski.

A letter of resignation from William Crone resigning from the Environmental Commission was accepted with regret on motion made by Durling, seconded by Boynton. All in favor. The Clerk was instructed to send a letter of thanks to Mr. Crone.

### **DEPARTMENT REPORTS:**

The yearly report of the Zoning Officer was reviewed by the Committee and was accepted on motion made by Boynton, seconded by Durling. All in favor.

Mayor Charles reported that he will meet with Mr. Desiderio and the DPW to get figures for the cost of the December 27<sup>th</sup> snow storm. Mr. Boynton felt that since this area did not receive the amount of snow closer to the shore area we should set an example and refuse the money. Motion was made by Durling, seconded by DeCarolis instructing the Mayor to prepare a letter of refusal. All in favor.

Mr. Durling brought up the Cable TV issue. He and Marty Connor will meet and come up with a list of requirements. Mr. Wacks was instructed to prepare a memo on our rights. Mayor Charles suggested that the Clerk contact each surrounding Mayor and ask if they would like to share the cost of an attorney to represent the towns. Motion was made by Boynton, seconded by DeCarolis instructing the Clerk to make this contact. All in favor.

Mr. Boynton suggested that a notice be sent out with the tax bills asking the residents to clean up the litter on their section of road. Motion was made by Boynton, seconded by DeCarolis to include this request along with placing on the website. All in favor.

Mr. Boynton brought up the subject of limiting audience participation to 5 or 10 minutes without an audience member passing their time over to another member. Motion was made by Durling, seconded by Boynton to not limit the time. Roll call: DeCarolis-yes, Desiderio-yes, Durling-yes, Boynton-no, Charles-no.

The Mayor thanked Mr. Desiderio for personally removing a boulder off of Kerrs Corner Road. The Mayor also thanked Mr. Durling for his services and leadership while Mayor.

The Municipal Clerk asked the Committee for their guidance on what to put on the township sign as the requests that have been made will not fit on the board. Since there have been complaints about the sign, all complaints will be sent to the Deputy Mayor.

# Municipal Engineer's report:

Mr. Sterbenz will put together a list of items he needs to talk to the road department about.

# Municipal Attorney's report:

Mr. Wacks reported that Kids Camp had filed a motion seeking to amend the complaint to add claims for fraudulent concealment/spoliation of evidence and for violation of civil rights. Judge Coleman denied the application. Mr. Wacks also thanked the committee for reappointing him.
