- 6. A provision authorizing COAH to direct trust funds in case of non-compliance per N.J.A.C. 5:97-8.3(h).

Mayor Durling proclaimed the month of May as Older Americans month in Frelinghuysen Township.

Due to the initial contract being fulfilled and the lump sum fee of \$10,450.00 being expended by Maser Consulting for the Housing Element and Fair Share Plan and plan adjustments are necessary, authorization is needed to proceed on the follow-up work at a cap figure of \$2,500.00. Mayor Durling brought the sidewalk issue up to date. The Mayor and Engineer have met with the Barbour's and the Engineer was instructed to contact SHPO to proceed with the gravel walkway.

Committeeman Natyzak-Osadca asked the outcome of the truck traffic on Saddle Ridge Road. The Mayor advised that the Engineer gave him a figure of \$3,500.00 for a study for the weight limit.

Mayor Durling reported that the school board elections are next week and the North Warren budget will be increased by 4.2% and the Frelinghuysen Township School will have no increase.

NEW BUSINESS:

The legal services agreement for attorney David Burton Brady to represent the Board of Adjustment was approved for the Mayor's signature on motion made by Boynton, seconded by Desiderio. All in favor.

A proposal to provide professional engineering and land surveying services for the third phase of the State Park Road Improvement Project in the amount of \$29,000.00 is on hold for the May meeting in order to provide Committeeman Desiderio time to renegotiate the fee.

The Clerk advised the Committee of a joint meeting to be held on April 30, 2009 with the Planning Board in order to amend the Housing Element and Fair Share Plan.

The Construction Office recommended to the Committee that the Plumbing fees be increased due to the State increasing their fees. Approval was given on motion made by Boynton, seconded by Desiderio. All in favor.

An insurance proposal for recreational activities was approved on motion made by Desiderio, seconded by DeCarolis. All in favor. Committeeman Boynton will clarify for the Committee whether this covers coaches and the charge per child.

The minutes of the budget meeting of March 25, 2009 were approved on motion made by Boynton, seconded by DeCarolis. All in favor.

DEPARTMENT REPORTS:

Department reports received from the Tax Assessor, North Warren Court, Knowlton Court, Warren County Health Dept., Dog Licensing Official, Building, Dept. and Recreation Committee were approved on a consent agenda motion made by Boynton, seconded by DeCarolis. All in favor.

Mayor Dale Durling's report:

Mayor Durling reported that he met with the various rescue squads and fire companies with regard to coverage due to Green Township not being able to cover the distance to the Lincoln Laurel Road area. 9-1-1 Coordinator Fran Muller presented a map with changes that Blairstown will now cover the Lincoln Laurel Road area along with Hope having additional coverage. Motion was made by Desiderio, seconded by DeCarolis authorizing the Mayor to sign the new 9-1-1 maps. All in favor.

Deputy Mayor Frank Desiderio's report:

Deputy Mayor Desiderio reported that another bulldozer is being donated to finish the recreational field for which a temporary equipment operator will be needed. A profiler is also being donated by Mr. Freeborn. Committeeman DeCarolis asked if the field is being limed and if so, he will obtain prices

Deputy Mayor Desiderio reported that the Road Department is now certified by PEOSHA and internet service is needed in the garage. The Clerk was instructed to order. Also, needed were safety items.

Committeeman Alan DeCarolis report:

Committeeman DeCarolis commended Mayor Durling on the work he has done in trying to get the sidewalk issue finalized.

Committeeman Debra Natyzak-Osadca's report:

Committeeman Natyzak-Osadca reported on an April 1, 2009 joint meeting with the Open Space and Farmland Preservation boards. The Land Conservancy of New Jersey is requesting that a letter be sent to a property owner on Route 519 (Dark Moon Road) asking if they are still interested in preserving their property. Motion was made by Boynton, seconded by Desiderio authoring Natyzak-Osadca to contact Megan at the Land Conservancy to send the letter. All in favor.
