MINUTES OF MEETING OF APRIL 18, 2007

Under the provisions of the Open Public Meetings Act, adequate notice of this meeting was provided by posting notice on the Township bulletin board and by faxing notice to the Star Gazette and New Jersey Herald on January 8, 2007.

The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Route 661, Johnsonburg, New Jersey and was called to order at 7:30 p.m. by Deputy Mayor David Boynton.

Those present were: Deputy Mayor David Boynton, Committeeman Debra Natyzak-Osadca, Attorney Edward Wacks, Chief Finance Officer Gene Marie McCartney, Auditor Anthony Ardito and Clerk Brenda Kleber. Mayor Thomas Charles was absent.

ADOPTION OF 2007 BUDGET:

Motion was made by Natyzak-Osadca, seconded by Boynton to open the meeting to the public for the adoption of the 2007 budget. All in favor. Auditor Anthony Ardito explained that the 2007 budget appropriations will be \$1,325,611, however, the actual tax rate impact would be zero. Motion was made by Natyzak-Osadca, seconded by Boynton to adopt the budget. All in favor

BOND ORDINANCE (#2007-09) PROVIDING FOR VARIOUS 2007 CAPITAL IMPROVEMENTS, BY AND IN THE TOWNSHIP OF FRELINGHUYSEN, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY; APPROPRIATING \$89,700 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$82,215 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF. WHEREAS, N.J.S.A.40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C.5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C.5:30-7.2 thru 7.5 the Township of Frelinghuysen has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township of Frelinghuysen meets the necessary conditions to participate in the program for the 2007 budget year,

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Frelinghuysen that in accordance with N.J.A.C.5:30-7.6a & b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 2. That the provisions relating to limitation on increases of appropriations pursuant to <u>N.J.S.A.</u>40A:45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met (Complies with the "CAP" law.)
- 3. That the budget is in such form, arrangement and content as required by the Local Budget Law and N.J.A.C. 5:30-4 AND 5:30-5.
- 4. That pursuant to the Local Budget Law:
 - All estimates of revenue are reasonable accurate and correctly stated:

A Mayor's proclamation proclaiming April 28-May 6, 2007 as National Safe Kids Week in New Jersey was concurred on motion made by Natyzak-Osadca, seconded by Boynton. All in favor.

A Mayor's proclamation proclaiming April 2007 as Child Abuse Prevention Month was concurred on motion made by Natyzak-Osadca, seconded by Boynton. All in favor.

A Mayor's proclamation proclaiming the month of May as Older Americans Month was concurred on motion made by Natyzak-Osadca, seconded by Boynton. All in favor.

A Mayor's proclamation proclaiming the month of June as Myasthenia Gravis Awareness Month in New Jersey was concurred on motion made by Natyzak-Osadca. All in favor.

OLD BUSINESS:

At last months meeting, Committeeman Natyzak-Osadca stated that she would follow up with the Tax Assessor as to why property consisting of approximately 15 acres and is landlocked, the owner is unknown, the property is not in farmland assessment and as the municipality is paying county taxes why couldn't this be under farmland assessment. David Gill, the tax assessor advised that unless there is farming activity on the property, the township cannot assess farmland values.

A proposal for professional services for the Phase II on State Park Road will be held until the Mayor is attendance. (Note: See April 25, 2007 meeting).

The Municipal Clerk inquired of the Committee that due to the death of Mayor Emeritus Charles Rydell, who would be responsible for the selection of the recipient of the Charles E. Rydell Scholarship. The Committee decided they would be responsible for the decision and would look over the selection at the meeting of April 25, 2007. (See resolution 2007-39)

The re-adoption of Bond Ordinance 2006-22 for State Park Roadwas opened to the public on motion made by Natyzak-Osadca, seconded by Boynton. All in favor. The Attorney explained that when the required supplemental debt statement was sent to the Dept. of Community

Committeeman Boynton asked for approval for a one day extension to reach out to Mr. Kapitko. Motion was made by Natyzak-Osadca, seconded by Boynton authorizing Mr. Boynton to contact Mr. Kapitko. All in favor. (Note: Fees were paid two days later)

The Municipal Clerk inquired of the Committee as to whether they would like to have a dog canvass this year since there hasn't been one done in many years. It was decided that the Clerk would obtain proposals.

NEW BUSINESS:

A letter of proposal to do an in rem tax sale foreclosure for the four tax sale certificates we currently have was read. The attorney, Keith Bonchi, quoted a cost of \$750.00 per foreclosure, plus costs assuming the title is not overly complicated. It was decided to carry this over to next months meeting so that the township attorney would study the proposal.

A letter received from the Highlands Council was read inquiring whether Frelinghuysen Township may be interested in pursuing a grant opportunity being developed by the Highlands Council to provide both financial and technical assistance to those municipalities that wish to explore the possibility of designating a TDR (Transfer of Development Rights) receiving zone. After discussion, it was decided that the Committee is not interested.

A letter from the Green Acres program informing the township that the Green Acres funds awarded on July 28, 2006 has been appropriated and the agreement need to be reviewed for accuracy along with the required signatures. Motion was made by Natyzak-Osadca, seconded by Boynton authorizing the Attorney and Mayor to sign the agreement. All in favor.

DEPARTMENT REPORTS:

Department reports received from the Tax Assessor, Tax Collector, Building Dept., Warren County Health Dept., Dog Licensing Official were approved on a consent agenda motion made by Natyzak-Osadca, seconded by Boynton. All in favor.

Paul Sterbenz's report:

The status of South Street is that the first increment which was that the topo maps will be completed in a couple of weeks, the next increment is that the wetlands need to be delineated and after that design plans will be started.

Attorney Edward Wacks report:

Mr. Wacks advised that he has delivered to the Township the title and deeds to the newly purchased 5 acres.

Mr. Wacks turned over to the Clerk correspondence expressing the firm of Connell Folley of Roseland, New Jersey interest in serving as Special Labor Counsel for the Township. This will be taken under consideration and discussed at the next meeting.

Mayor Thomas Charles report:

The Clerk read into the record the following Mayors report:

The Mayor asked that everyone's hearts and prayers go out to Governor Corzine after his automobile accident and the families of those massacred at Virginia Tech. The Mayor will ask EMC Nancy Predale, to contact the schools to review plans for emergencies in light of the tragedy at Virginia Tech.

With regard to the Mayor Conference he attended, a waiver for the 3rd round for COAH is needed by May 24th along with directing Planner John Madden to meet with the Commerce dept. To talk about the creamery as an enterprise zone for grant money. The Clerk was instructed to contact Mr. Madden.

With regard to the Conference on April 14th he challenged the boards and commissions to move Frelinghuysen from good to great. Introduced at the conference was the new web site with new e mail address.

Mayor Charles recommended that Sister Miriam McGillis be appointed to the Environmental Commission. The Clerk will contact Sister McGillis.

Mayor Charles wished to thank the public works for their dedicated work they provided during the large rainstorm. He also thought we should reach out to Blairstown to see if they need any help with the flooding.

Committeeman Boynton's report:

Committeeman Boynton reported on the March 14th meeting held at the Presbyterian Camp and gave an overview of the meeting.

With regard to Recreation, Casino Night was a success, Founders Day picnic will be held on June 2nd, and the pavilion should have the concrete floor poured in the next couple of weeks.
