WHEREAS, The Nature Conservancy is the owner of Block 1001, Lot 15 in the Township of Frelinghuysen (the "Property"); and

WHEREAS, the Property possesses open, natural, ecological and educational value; and WHEREAS, the Township of Frelinghuysen and The Nature Conservancy recognize the value and special character of the Property and acknowledge a common purpose to conserve the value of the Property; and

WHEREAS, the Nature Conservancy, as owner of the Property intends to convey the Property to the Township of Frelinghuysen; and

WHEREAS, the Township of Frelinghuysen has agreed to grant and convey unto The Nature Conservancy a Conservation Restriction over the Property in accordance with N.J.A.C.13:8B-1 <u>et seq.</u>, in order to preserve and protect the conservation values of the Property in perpetuity; and

WHEREAS, as such, The Nature Conservancy shall execute a Deed conveying the Property to the Township of Frelinghuysen; and

WHEREAS, the Township of Frelinghuysen shall execute a Conservation Restriction over the Property;

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Township Committee as follows: 1. The Township hereby accepts the Deed from The Nature Conservancy conveying Block 1001, Lot 15 to the Township. The Mayor and Clerk are hereby authorized to execute said Deed.

2) The Township agrees to grant and convey unto The Nature Conservancy a conservation restriction on Block 1001, Lot 15. The Mayor and Clerk are hereby authorized to execute a Conservation Restriction between the Township and The Nature Conservancy.

3) This Resolution shall take effect according to law.

#2007-51

WHEREAS, the Open Space Advisory Commission was created by passage of Ordinance 2006-12 on July 19, 2006 to carry out the approved Open Space and Recreation Element of the Frelinghuysen Master Plan; and

WHEREAS, the Open Space Advisory Commission site committee viewed the 35.56 acre property to ascertain its possible open space and recreation uses; and

WHEREAS, the Open Space Advisory Commission believes that the property is suitable for fulfilling passive and active recreation and open space needs in the community; and

WHEREAS, the Frelinghuysen Open Space and Recreation Plan recommends the township actively pursue acquisition of land adjacent to the Paulins Kill to protect the community's watershed.

NOW, THEREFORE BE IT RESOLVED, by the Open Space Advisory Commission of the Township of Frelinghuysen on the 16th day of May, 2007 to request that the Township Committee support the development of a grant to the Warren County Municipal and Charitable Conservancy Trust to be used in the acquisition of Lot 3, Block 103 owned by Jerome L. Reisberg for the purpose of providing active and passive recreation and open space for the residents of Frelinghuysen Township.

Motion was made by Boynton, seconded by Natyzak-Osadca offering this resolution. Roll call vote: Boynton-yes, Natyzak-Osadca-yes, Charles-yes.

OLD BUGINESS.

It was determined that the 1.894 acres located behind the ballfield on Township property and was thought to have been conveyed to the township by Nature Conservancy does not have a deed. The attorney was authorized to prepare a deed for Nature Conservancy to sign conveying the 1.894 acres to the township. Motion was made by Boynton, seconded by Natyzak-Osadca accepting the offer from Nature Conservancy for the 1.894 parcel to be added to Block 1001, Lot 15 and authorizes the Mayor and Clerk to enter into a restriction agreement entitled "Conservation Restriction". All in favor. (See resolution #2007-50)

A discussion ensued on the ownership of Pippin Hill Road. Committeeman Natyzak-Osadca feels that it was not properly vacated along with Camp Weaqua (from Bear Creek Road to Allamuchy Road). The attorney recommended a metes and bounds description. It was decided that on motion made by Boynton, seconded by Natyzak-Osadca, the attorney would prepare an ordinance and the Clerk will draft a letter to adjoining property owners asking them to bear the expense of preparing the description and ordinance. All in favor.

Committeeman Natyzak-Osadca asked if the 9-1-1 map is the correct dated map. Mayor Charles advised that the 9-1-1 dispatch had approved the map.

The Kerrs Corner Road exchange for Route 661 was discussed. The Mayor thought Ackerson Road may be more attractive to the County. On motion made by Boynton, seconded by Natyzak-Osadca the Clerk was instructed to write a letter to the County for their interest in the exchange. All in favor.

With regard to the Solar thermal Ordinance, Committeeman Boynton would like to see if there is any interest in the wind generators first. On motion made by Boynton, seconded by Natyzak-Osadca, the attorney will review the ordinance along with referring the ordinance to the Planning Board for their review and comment. All in favor.

The proposal for the four In Rem foreclosures received from the firm of Goldenberg, Mackler, Sayegh, Mintz, Pfeffer, Bonchi & Gill for a cost of \$750.00 per foreclosure was discussed. The attorney advised that he will do for the same price. On motion made by Boynton, seconded by Natyzak-Osadca the attorney was authorized to submit a proposal for next months meeting. All in favor.

The Charles E. Rydell scholarship selection is being held for Executive Session.

NEW BUSINESS:

Residents of Saddle Ridge Road were to appear before the Committee requesting a lowering of the present speed limit of 25 MPH. The Committee felt that the speed limit is sufficient and will contact the State Police.

Emergency Management Coordinator Nancy Predale submitted a copy of a flood mitigation letter she will be sending to residents. There is no formal action needed, Ms. Predale just want the Committee to be informed.

A letter received from the NJDOT announcing that applications will be accepted for the NJDOT's Local Bikeway Program for municipalities to apply for funds was read. It was decided that this would be given to the Recreation Committee.

Copies of updated checklists for Planning/Zoning Board applications were presented to the Committee. It was decided that they would be held for Planning Board approval before any action could be taken.

The North Warren Garden Club submitted suggestions for plants at the corner of Route 661 and 519. The project would costs \$350.00 and the funds will be taken out of the Clean Communities account.

Robin Randolph, Chairman of the Open Space Committee approached the Committee with a history of the proposed acquisition process of the Reisberg property. Three bid proposals were sent out on April 25th to state approved appraisers. Motion was made by Boynton, seconded by Natyzak-Osadca approving the appraisal received from Robert Heffernan and authorizing the payment to be taken out of the Open Space account in the amount of \$3600.00. All in favor. A resolution was submitted that must be approved before Morris Land Conservancy can apply to the County for funds. (See resolution #2007-51)

The Open Space Committee proposed funding options to complete the Reisburg property - see attached options. Additionally, was a request that the Township Committee approve an increase in the Township Open Space/Farmland Preservation tax by \$.02 per \$100.00. Motion was made by Natyzak-Osadca, seconded by Boynton instructing the Clerk to prepare a resolution for the June meeting. All in favor.

John Burlazzi, Director of Facilities and Michelle Russo, Director of Adult Services of the Metheny School, Greendell Road appeared before the Committee to discuss a situation where there have been numerous false alarms and would like to resolve the matter. Since there has been over 24 false alarms over the past year, these are costing the township additional funds as the fire company and first aid squad must respond and this will be taken under consideration during the budget process. Mr. Burlazzi stated that they have addressed several of the suggestions made by the building inspector and may have to look into the wiring as the false alarms are still happening. It was suggested that Mr. Burlazzi, the Green Township Fire Chief and the building inspection set up a meeting to identify the problems and come up with a recommended list. The Mayor will set up the meeting.

Mayor Charles presented a plaque to Deputy Mayor Boynton for his outstanding service to the Committee for the year of 2007.

Paul Sterbenz was requested to prepare a proposal for the development of the recreation campus. He would like to meet with the recreation committee to discuss a phased in plan in light of the possible designation of Bear Creek to a C1 stream category.

The Mayor proposed a Clean Frelinghuysen Day to coincide with Earth Day next year. This will be discussed further as the date gets closer.

Committeeman David Boynton's report:
