The regular meeting of the Frelinghuysen Township Committee was held in the Municipal Building, 210 Route 661, Johnsonburg, New Jersey and was called to order at 7:30 p.m. by Mayor Charles.

# EXECUTIVE SESSION:

The Executive Session was held at 7:00 p.m. Notice was sent to the Star Gazette and New Jersey Herald along with posting notice on the Township bulletin board on July 13, 2007. Motion was made by Boynton, seconded by Natyzak-Osadca to enter into Executive Session with regard to possible litigation after a resolution was approved in the public portion of the meeting. Upon returning the attorney advised that the meeting involved a discussion on the Barbour's title which is in the process of being completed. Further discussion will take place when the title search is completed. An additional appraisal on the Reisburg property was authorized in the amount of \$3,000.00 on motion made by Boynton, seconded by Natyzak-Osadca. All in favor.

WHEREAS, there exists a need for legal services in addition to those already provided by the Township Attorney, Edward Wacks, Esq. of Wacks & Hartmann, LLC, specifically, the representation of the Township in foreclosure of tax sale certificates; and

WHEREAS, said need is for certain specified professional services to be rendered or performed by a person or persons authorized by law to practice a recognized profession, whose practice is regulated by law within the meaning of <u>N.J.S.A.</u> 40A:11-2 <u>et seq.</u>, as amended; and

WHEREAS, the performance of said professional services requires knowledge of an advanced type in a field of learning acquired by a prolonged formal course of specialized training and study, as distinguished from general academic instruction or apprenticeship and training; and

WHEREAS, said professional services cannot reasonable be described by written specifications; and

WHEREAS, the budget of said board duly appointed and approved by the Mayor and Township Council provides generally for funds for the services of such professional and/or certain escrow accounts paid by applicants for development provide for the payment for such services; and

WHEREAS, the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1, <u>et seq.</u>, as amended, requires that this Resolution authorizing the award of contract for "Extraordinary, Unspecifiable Services" without bids and the contract itself must be available for inspection and be publicly advertised.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Frelinghuysen, Warren County, New Jersey as follows:

 The Township of Frelinghuysen in accordance with the Local Public Contracts Law <u>N.J.S.A.</u> 40A:11-1 <u>et seq.</u>, as amended, hereby authorizes and approves the award of professional services contract to Wacks & Hartmann, LLC for the representation of the Township in the foreclosure of tax sale certificates, in accordance with the proposal attached hereto at Exhibit A and the professional services contract between the parties. Said contract is hereby ratified and confirmed, and upon passage of this Resolution, the Mayor and Township Clerk be and the same are hereby authorized to enter into said contract with the firm of Wacks & Hartmann, LLC.
 This contract is awarded without competitive bidding as an "Extraordinary Unspecifiable Service" in accordance with <u>N.J.S.A.</u> 40A:11-1, <u>et.seq.</u>, as amended, of the Local Public Contract Law because the services required cannot be reasonably described by written specifications to assure that the qualitative and quantitative assessment of the problems involved, which require expertise, extensive training and proven reputation in the field of endeavor are obtained.

3. A copy of this Resolution shall be published as required by law. Motion was made by Boynton, seconded by Natyzak-Osadca to approve said resolution. Roll call vote: Natyzak-Osadca-yes, Boynton-yes, Charles-yes.

#### #2007-65:

WHEREAS, American Family Life Assurance Company ("AFLAC") has offered to provide supplemental insurance benefits to Frelinghuysen Township employees, including, but not limited to, supplemental accident, sickness and disability; and WHEREAS, any benefits selected by municipal employees shall be paid for on a payroll basis, i.e. shall be paid directly from the employees' pay, so that offering these benefits will not result in any cost to the Township of Frelinghuysen; and

WHEREAS, the AFLAC program thus offers the Township the opportunity to enhance the benefits available to its employees, without any negative effect on the Township's budget or any increase in taxes.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Township Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey as follows:

1). The Mayor and Committee hereby authorized AFLAC to offer its benefits to Township employees, with the express understanding that such benefits selected by the employees shall be paid by the employees at no cost to the Township, and that there shall be no contractual relationship between AFLAC and the Township.

2). This resolution shall take effect according to law.

Motion was made by Boynton, seconded by Natyzak-Osadca to approve said resolution. Roll call vote: Natyzak-Osadca-yes, Boynton-yes, Charles-yes.

# **PROCLAMATION:**

A proclamation proclaiming September 2007 as National Alcohol and Drug Addiction Recovery Month in September was approved on motion made by Boynton, seconded by Natyzak-Osadca. All in favor.

#### OLD BUSINESS:

A quotation in the amount of \$4,700.00 for a camera surveillance network for the area behind the Municipal building was reviewed by the Committee. It was decided that Committeeman Boynton would obtain additional quotes. A suggestion to obtain a grant for the surveillance equipment was discussed.

The cell tower ordinance will be on hold for next month's meeting. Committee Boynton would like to adopt an ordinance placing cell towers on municipal property so that the municipality can benefit from the fees.

A letter requesting the monies owed from a letter of credit and escrow balances from Bedrock Construction was read. Concerns over Lackawanna Drive was brought up and the Clerk was instructed to contact Engineer Paul Sterbenz. A letter received from Warren County was read informing that the County was awarded \$400,000.00 to conduct a needs assessment, records inventory, and strategic plan process for all municipalities in the county that chose to participate. Since Frelinghuysen Township expressed an interest in participating preparations will be started before September.

Responses from a letter sent to the adjoining property owners along Old Bear Creek Road the township would like to vacate was read. Owners Mark Willis along with Stephen Gurba expressed an interest in taking ownership and would help with the costs. The attorney asked that copies be sent to his office. Motion was made by Boynton, seconded by Natyzak-Osadca authorizing the attorney to order a title search and prepare an ordinance. All in favor.

The Clerk informed the Committee that there was over \$23,000.00 in the Dog Trust Account which could be used for the Dog Census. Motion was made by Boynton, seconded by Natyzak-Osadca accepting the submitted proposal. All in favor.

### **NEW BUSINESS:**

Caryn Beam and Tim Mc Andrews of AFLAC appeared before the Committee for a proposal to present to the employees a plan to provide additional health insurance at no cost to the township. Motion was made by Boynton, seconded by Natyzak-Osadca authorizing the AFLAC program to be offered to the municipal employees on a payroll basis and authorizing the attorney to prepare a resolution dealing with this program. All in favor.

Robin Randolph, Chairman of the Open Space Committee presented a rationale on the Open Space tax increase. Ms. Randolph advised that the increase would cost the average assessed home and additional \$42.14 per year or \$3.50 a month based on a house assessed at \$211,000.00.

Road Supervisor Frank Desiderio advised the Committee that the Road Department is in need of an additional tractor and sicklemower. The Clerk was instructed to advertise on motion made by Boynton, seconded by Natyzak-Osadca. All in favor.

A letter received from the Office of the Warren County Engineer was read advising that a contract to Denville Line Painting was awarded to install pavement markings and this is being offered to municipalities. Mayor Charles stated that we will be striping 5 miles or spending \$5,000.00. The Mayor will meet with the Road foreman for a list of roads that are in need.

A letter received from the Frelinghuysen Township Planning Board was read asking the Committee for their support by sending a letter to the Warren County Planning Board supporting the restoration of the porch on the Johnsonburg Inn. Motion was made by Boynton, seconded by Natyzak-Osadca authorizing the Mayor to send a letter of support to restore the porch. All in favor.

A proposal for professional services to provide professional engineering, environmental science and land surveying services for the South Street Pond Improvement project in the amount of \$5.500.00 was approved on motion made by Boynton, seconded by Natyzak-Osadca. All in favor.

#### **DEPARTMENT REPORTS:**

Department reports received from the Tax Assessor, tax Collector, Building Dept., Warrren County Health Dept., Dog Licensing Official and the Municipal Court were approved on a consent agenda motion made by Natyzak-Osadca, seconded by Boynton. All in favor.

#### Mayor Thomas Charles report:

Mayor Charles announced the 2<sup>nd</sup> Family Night Out sponsored by the New Jersey State Police to be held on August 7<sup>th</sup> from 6:00 p.m. to 10:00 p.m. on Alphano Road in Allamuchy Township.

Mayor Charles would like to form a task force for the web site policies. The Mayor will ask that Robin Randolph along with John Jurena and Shannon Drylie be on this committee.

The Hope Court assess a \$6,000.00 negative, however, there was an insurance bill that had not been paid which reflected the negative balance.

Mayor Charles met with the road department and advised that a third worker is needed to handle the equipment . This will be further discussed at the special meeting.

A fire drill was conducted in the Johnsonburg area. The only weak part was the lack of water supply. A suggestion was to install an standing pipe in the pond located on Tom Finn's properties on Mill Road at the township's expense. This will be further discussed.

The Mayor reported on a rock removal incident on Stillwater Road. To date they have complied with the Mayor's request on the road conditions.

The Mayor reported on the 1<sup>st</sup> DPW picnic that Frelinghuysen Township sponsored. It was a round table discussion on shared services, training seminars, etc.

Committeeman David Boynton's report:

With regard to the Recreation Committee-it does not meet in the summer.

Committeeman Boynton dropped off the paperwork on the superfund site on Greendell Road. This will be further discussed in September.

Committeeman Boynton wished to compliment Robin Randolph on the organization of the Chipper party to clear the area for the proposed municipal complex.

Committeeman Debra Natyzak-Osadca's report:

Committeeman Natyzak-Osadca reported that the tax levy has increased by 4 cents. The 2007 rate is now \$2.17 per \$100.00 assessed value.

The Municipal Alliance grant has been prepared and is ready for the Committee's signatures.

Our portion of the Farmland Preservation for the Greene, Jensen and Smith properties will be \$110,232.00.

Road Supervisor Frank Desiderio's report:

Mr. Desiderio asked the Committee for approval to order uniform shirts and pants for the Road Department. The cost would be \$25.00 a week for two sets and includes cleaning and mending. This will be taken up further at the special meeting on July 25, 2007.

Mr. Desiderio also brought up the conditions of the air conditioners in the municipal offices. Currently, when they are turned on causes the breakers to turn off the electricity and also turns the telephones off. Committee Boynton will call the electrician.

The hiring of an in house mechanic for service on the township vehicles was discussed. It was decided to get clarification from the attorney on how to hire someone without receiving benefits.
