OLD BUSINESS:

A letter offering the Frelinghuysen Township the recreational use of the Dark Moon ball Field was read providing that the Township maintains the insurance and property. The Mayor instructed the Clerk to call each member of the Recreation Committee for their approval as Mrs. Predale needed the approval right away. (Note: Each member called gave their approval). The Mayor suggested an agreement be prepared outlining what is included in the maintenance of the property.

Six applications have been received for the Backhoe operator's position. An interview meeting will be scheduled for Thursday at 2:00 p.m. (Note: Wayne Waldron was hired for the position).

A proposal in the amount of \$14,000.00 was received from Maser Consulting was read providing engineering services to prepare a construction plan and soil erosion plan for Phase 1 of the Municipal Complex Improvements. See resolution above.

NEW BUSINESS:

Ruby Malcolm, Judy Pender, Paul Chipko and Fred Cook, members of the North Warren Board of Education gave a presentation on the referendum for the school. Mr. Chipao explained that the school was built to hold 941 students and the projections estimate that there will be 1186 students by 2009. The referendum is a two part question with the first question costing \$15,515,000.00 and adding 13 class rooms along with 2 new locker rooms, new boilers, wrestling room, 2 new science rooms and a technology room. The second question would cost \$3,336,000.00 and would add a weight lifting room, 2 new art rooms and a new music room with storage. If the referendum is defeated alternate options could be that 13 trailers costing \$3.25 million or implementing split sessions with some students attending from 7:30-1:30 while others

will attend from 11:30-5:30 which would double the transportation budget. Based on \$100,000.00 of assessment, the first question would cost the tax payers in Frelinghuysen \$58.00 and the second question would cost \$14.00 a year.

The Mayor brought up a situation which took place last week whereby two stray cats were reported by residents who wanted the Animal Control Officer to pick them up. When they were advised that the township does not regulate cats, they called the State Dept. of Health and the Clerk was advised that according to state statutes these cats must be impounded. Discussion took place on a policy that needs to be implemented along with the ACO advising that other municipalities have had to impound cats and it costs them as much as \$240.00 a cat. It was decided to refer this to the attorney to research and either come up with a policy or an ordinance which would fall within the guidelines of the state statutes.

A letter received from the State of New Jersey, Dept. of Agriculture advising that defoliation caused by the gypsy moth has been detected in Frelinghuysen Township was read. The Dept. of Agriculture offered to conduct gypsy moth egg mass surveys in the township with no charge for the inspection, however the township will be required to supply three copies of the municipal map to the inspection for the survey. The Committee approved the survey on motion made by Charles, seconded by Natyzak-Osadca. All in favor.

DEPARTMENT REPORTS:

Department reports received from the Tax Assessor, Tax Collector, Building Dept., Dog Licensing Official were approved on a consent agenda motion made by Natyzak-Osadca, seconded by Charles. All in favor.

Mayor Thomas Charles report:

Mayor Charles reported on a newly formed task force where policies and procedures were developed for the computers and web site. These will be sent to the employees.

The Night Out on August 7, 2007 was a success. The idea of rotating this will be discussed later.

The floor is finished on the pavilion which was done by Jack Blgos and Chip Greene.

The Mayor advised that the drainage projects are two months behind due to the breakdown of equipment. An additional person is being hired to help with the projects.

Committeeman Debra Natyzak-Osadca report:

Committeeman Natyzak-Osadca reported that most of the money has been received from Green Acres with regard to the five acre property. There is a grant to Green Acres for a 2% loan that she is applying for that will be used for the development of the ball field.

Attorney Christopher Hartmann's report:

Mr. Hartmann reported that the title examiner researching the Barbour's property concluded that the entire front of the Barbour's property runs to and along the sideline of the public road. It was decided that the Clerk would send a letter to the Barbour's advising this.

Mr. Hartmann advised that there are no conservation easements on the 1.89 acres donated by the Nature Conservancy. The deeds are being mailed to his office.

The deeds for Lackawanna Drive and Ramsey Court along with the Township property on Route 94 are being checked on.

Committeeman Natyzak-Osadca asked for an ordinance for the purchase of Farmland Preservation and how the money is spent. The attorney will look into this.
