A proclamation recognizing Angelo Leoncini for his commitment to the community by mowing and maintaining the Johnsonburg Park for the past 30 years was read. Motion was made by Boynton, seconded by Natyzak-Osadca concurring with the Mayor's proclamation.

### OLD BUSINESS:

With regard to last month's meeting on a communications policy, the attorney presented a draft policy for press releases and mailings for discussion only. There were several issues including who should review these items before they are mailed or sent for publication. There should also be a balance for some level of oversight against the right to free speech and the public's right to information. The Committee decided they would study the draft policy and resolution.

A noise ordinance adopted by the Township of Morris was presented by the attorney. The Committee will study.

A baseball field maintenance agreement was presented by the attorney. The draft copy was given to Mrs. Predale.

Two quotes were received for a snow plow. After reviewing the quotes, motion was made by Boynton, seconded by Natyzak-Osadca to order the plow from Tony Sanchez at an amount of \$4,640.00.

The draft copy of the personnel manual was presented by the attorney. The Committee will study.

It was stated that we have been paying an annual salary for the Tax Assessor to do reassessments, however, the County Board of Taxation has not authorize this and they have not done so. A request for the county to prepare a line item comparison report for the years of 2005, 2006 and 2007 was approved on motion made by Boynton, seconded by Charles. All in favor.

#### **NEW BUSINESS:**

The letter of resignation received from Charles Marra who was a member of the Open Space Committee was read and accepted with regret on motion made by Boynton,

seconded by Natyzak-Osadca. All in favor. The Clerk was instructed to send a letter of thanks for his commitment.

A letter received from the New Jersey State League of Municipalities was read requesting that a list be developed of the culverts located in the township and forward them to the county engineer for compilation. The Mayor advised that the township will comply with the request. (Note: After a conversation with the County Engineer it was noted that the culverts have to be over 5' in length. Since the township does not have any of this size we do not have to comply).

A letter received from the Township Environmental Commission was read requesting the Township's help in the usage of solar panels. The Mayor stated that we could explore the possibility of installing solar panels on the Town Hall if we could get a plan that would sell back the electricity. The Mayor also suggested that an ordinance be prepared.

### **DEPARTMENT REPORTS:**

Department reports received from the Tax Collector, Tax Assessor, Building Dept., Warren County Municipal Court, Dog Licensing Official and Warren County Health Dept. were approved on a consent agenda motion made by Boynton, seconded by Natyzak-Osadca. All in favor.

### Mayor Thomas Charles report:

Mayor Charles reported that the cross drain project is almost complete. He praised the road department for doing a great job along with saving the township a lot of money by installing these drains. The Mayor feels a special reorganization is in order. The Committee will take this under consideration.

Mayor Charles reported that the Highland's master plan is due out November 19<sup>th</sup>.

Mayor Charles reported on an accident which occurred on Kerrs Corner Road whereby several young boys committed destruction of state property and did harm to their selves. The Rescue squads, EMS, Building Dept. were on hand and did a great job. By Tuesday, the State had the property cleared of debris and the property is now safe.

Mayor Charles reported on a garage fire on Muller Road. Several area fire companies responded. The Mayor would like to write a letter in appreciation for the quick response.

# Committeeman David Boynton's report:

Committeeman Boynton complimented the Mayor on how the incident on Kerrs Corner Road was handled. Mr. Boynton suggested that we have NJDOT check into getting better communications with the townships.

Committeeman Boynton reported on the Fall Festival which is replacing the Hay ride. It will be held at the Town Hall this year.

#### Committeeman Debra Natyzak-Osadca's report:

Committeeman Natyzak-Osadca reported on the 2% loan application she has applied for on the Municipal Complex.

The Municipal Alliance will be holding their Halloween Open House in the Town Hall on Wednesday 5:00 p.m. to 8:00 p.m.

#### Engineer Paul Sterbenz report:

With regard to the status of the SHPO application to allow for sidewalks to be extended on Main Street to the Municipal Complex, Mr. Sterbenz reported that he had prepared a draft SHPO report that was sent to the County for their review. Engineer Mr. Hicks responded with comments and additions. Photographs are to be taken and submitted to the County and they will be forwarded to SHPO. The foot-work may be done this fall but still need SHPO's approval before we can proceed. The status of Phase 2 on State Park Road is that the job has been designed and Mr. Sterbenz is checking it over. It will then be sent to the NJDOT.

With regard to the South Street project the wetlands have been delineated and they are assessing the environmental issues. A meeting will need to be held in the future with regard to the pond that is closest to the homes as the berm is not a good idea.

With regard to the Municipal Complex, all scopes of work such as the master plan, construction plan (phase 1), soil conservation and the issuance of the building permit have been completed.

With regard to the right-of-way on Old Bear Creek Road, there is nothing on the tax maps which shows the ROW. There will be a cost of \$2,500.00 for legal fees, cost of survey and metes and bounds description. It was decided that a letter would be sent to the adjoining property owner advising him of the cost. A professional agreement will be sent by Maser Consulting.

The Mayor asked Mr. Sterbenz who is responsible for the trees along the sidewalk area on Saddle Ridge Road as the trees need to be trimmed. It was advised that they belong to the Township as they are in the right-of-way.

Mr. Sterbenz was advised of repair being needed on a retaining wall which is located in the right-of-way along Mill Road. The Mayor will meet with Mr. Sterbenz at a later date.

The vacating of Kishbaugh Road, Pittenger Road and Katzenstein Road was discussed. Motion was made by Boynton, seconded by Natyzak-Osadca to contact the property owners for the expense of vacating these roads. All in favor.

#### Attorney Richard Beilin's report:

Mr. Beilin reported that with regard to the Beer Keg Ordinance that municipalities were asked to adopt is against the ABC laws.

Mr. Beilin reported on the definition of Blue Acres that is included in the resolution endorsing the Green Acres, Farmland, Blue Acres and Historic Preservation Bond (see resolution #2007-73).

Mr. Beilin reported that the present sign ordinance is in need of revision. He will supply a sign ordinance from adjoining townships.

The non-conforming ordinance (#2007-15) needs further clarification. Mr. Beilin will contact Mr. Lavery, the Planning Board attorney. There was also a question on the Right to Farm Ordinance (#2007-14).

After reviewing the two submitted cell tower ordinances, the attorney thought that the ordinance from Hardwick would be the better one. Mr. Beilin felt that there would be a legal problem with the ordinance if the tower was on property other than the township as the restrictions in the ordinance would be overwhelming.

With regard to the outdoor festivals, Mr. Beilin found a set of regulations. The Committee will review them.
