Mr. Lavery answered the Board could Deed restrict 20% of the remaining property, however, he reminded the Board the applicant came in with a conforming lot, and at the Board's direction, the lot size was reduced. New plans submitted January 16, 2008. Application deemed complete at January 7, 2008 Meeting. Notice to surrounding property owners carried from previous meeting.

Mr. Gold understands the application is close to a vote, and asked for any comments from the Board.

Mr. Boynton asked if the Site Committee had any comments as they were at the property. Mr. Kleber stated there is a concern with the flag stem and the access strip. The Site Committee was concerned there could be two driveways side by side. Mr. DeCarolis added the Site Committee's recommendation is the applicant would merge, or clean-up, the flag stem.

There was discussion regarding deed restricting the remaining to a one lot subdivision. Mr. Darling answered he would be agreeable. Mr. Gold asked if Mr. Darling understood what he was agreeing to. Mr. Darling answered yes. He would deed restrict the remainder lot to a one lot subdivision.

Mr. Golden was asked if there was any other information he was waiting for from the applicant. Mr. Golden answered all the items on his final report have been addressed.
