Mr. Mills stated there was a question regarding the Variance and whether or not it would have to be amended. Mr. Lavery advised the Board that new notice would be needed for the April 2, 2007 Regularly Scheduled Meeting.

Mr. Mills asked Mr. Joseph McEvoy to review the changes to the plan with the Board. Mr. McEvoy stated:

- 1. The septic is now along the side of the property line;
- 2. Courtyard is now reduced;
- 3. One story structure will now be demolished;
- 4. Parking lot will remain the area.

Mr. Golden stated there has been significant improvement to the details of the plans.

There was discussion regarding the retaining walls: materials to be used; design concerns due to the fact that the walls would be over four feet high. Applicants are waiting for County approval with regard to the front porches of the Inn.

Mr. Golden stated the Applicant is proposing two lots with a remainder. For Completeness the application requires 100 scale, and 200 scale has been provided. There were concerns regarding critical areas: stream and wetlands. The Applicant has requested a 100' buffer, however, 150' is required. There was further discussion regarding the wetlands and the driveway.

Mr. Rogers stated to the Board once again, as with the previous subdivision, the property is not going to be sold. The Applicant is applying for the subdivision in order to protect himself from the Highlands.

The Applicants were told the following needs to be shown on the plan:

- 1. Wetland flagging;
- 2. Topos of six acre lots;
- 3. Scale to be 100';
- 4. Information needed regarding the stream

Mr. Golden recommended the Application be deemed Incomplete, as further information is required.

A motion was made by Ms. Randolph, seconded by Mr. Boynton, to deem the Application Incomplete. The vote is recorded as follows:

Rogers,/Peaceful Valley Farms - Block 301, Lot 14 - Minor Subdivision - App. #07-04

Mr. Golden stated the same issues remain as the previous Application. Another issue is the majority of the building envelope for Lot 14.05 is in the critical slope area. Mr. Golden would like to see on the plan points showing the common driveway. There are steep slopes where the driveway is being shown now.
