## SUBCOMMITTEES/LIASON REPORTS

Open Space - Robin Randolph. Awaiting Environmental Assessment Reports with regard to the Reisburg property.

**Environmental** – Patricia Fleno. Ms. Fleno was absent from the last Environmental Meeting.

Site Committee – Alan DeCarolis no new applications for site committee visit.

Rural Character/Sign Ordinance –Robin Randolph & Donna Eitner – Wind Turbine Ordinance. A Draft Solar/Wind Turbine Ordinance was sent via e-mail to Board Members by Mr. Golden, dated December 4, 2009. Ms. Randolph addressed the changes the Board requested Mr. Golden make to the previous Draft Ordinance. There was discussion regarding buffering of solar panels in back yards (100%); the maximum size of solar panel arrays; specifics of front yard setbacks, and if variances were needed for front yards. Ms. Drylie was asked to poll the Board if the members felt a Variance would be needed for a front yard array, instead of the property owner coming before the Board to present their case as to a hardship for not placing it in the rear yard. The results of the poll are as follows:

DeCarolis - No Desiderio - No Young - No Zilberfarb - No Barrow - No Fleno - No Corvino - No

There was discussion as to the placement of wind turbines on properties; front yard setbacks for large pieces of property.

Mr. Golden was asked to make recommended changes to the Draft Ordinance and have it ready for the Work Session Meeting to be held on December 29, 2009.

**Farmland** – Robert Young – there have been no meetings, however, there may be a few landowners backing out due to the appraisal process. The landowner wants to preserve the land with the Township, they need to sign an agreement

with the Township that if they opt not to accept the contract, they must pay half the cost of the appraisal.

**Outdoor Boilers** – Frank Desiderio – nothing to report.

The Professionals and Ms. Drylie were advised there would be discussion regarding their reappointments at the Work Session Meeting on December 29, 2009. Ms. Drylie will be *Rice Noticed* by Mr. Lavery's office prior to the Meeting. The Professionals need not be *Rice Noticed* as they are not employees of the Township.
